9	Grounds of the present appeal.	The applicant filed RTI Application on 09/09/2015. No reply was given to the applicant after lapse of 30 days.
10	Prayer in the present appeal.	CPIO may applied be directed to supply the information immediately.
11	Observations and comments of Appellate Authority.	In the RTI appeal dated 28/10/2015, Applicant appealed that information was not provided to him in 30 days. In the reply of CPIO dated 30/10/2015, he has accepted that reply to the applicant was delayed inadvertently and has expressed his regret for the same. From the above it is clear that the RTI application was replied to the applicant by the CPIO, when the first appeal in the case was made to FAA.
