Delhi Metro Rail Corporation has embarked on its Phase III project comprising about 140 km of network scheduled to be completed by 2016. The work of Phase III is in full swing. DMRC is in urgent need of services of one experienced Electrical Engineer on deputation basis at Delhi/NCR.

The details of the post are shown below:

- The officer should belong to Electrical cadre & should be working in Grade 37,400-67,000 CDA with grade pay of Rs. 10,000 (SAG or NFSAG) or working in Grade 37,400-67,000 CDA for 8 years with grade pay of Rs. 8,700 (SG)
- The candidate must have extensive experience in electrical department including contract, electrical installations, maintenance etc.
- Candidate should be free from vigilance/D&AR angle.

DMRC has aligned its policy regarding pay and allowances of deputationists with the existing policy of DOP&T. The officers selected on deputation will only be eligible to draw their parent department's pay plus deputation allowance as admissible and no higher/pay scale of DMRC will be granted to them, unless they get promotion in their parent cadre.
