A Web portal www.ccms-dot.gov.in has been launched for DoT Court Case Monitoring System (CCMS) on 25/05/2016. This is very vital and real time web based application, for effective monitoring of all ongoing pending court cases of DoT (H/Q) and it's field units i.e. TERM/CCA/Other units across the country.

- (2) The CCMS of DoT will broadly perform following functions:
 - Monitor the progress of all court cases.
 - Web enabled system to collect all information on Court cases.
 - Generates various queries and reports based on court, case, wing wise.
 - All level of MIS and alerts.
- (3) Three types of users can be created in the system i.e.
 - (i) Entry User: User for data entry for a particular section/wing.
 - (ii) Admin User: User can see all types of reports of a particular Wing/Division.
 - (iii) Advocate User: User Id & Password for nominated Advocate.
- (4) This portal having special important features as mentioned below:
 - a. Password change option available on main page for all users.
 - b. Entry user can update the court proceedings of individual case through **Case List** as well as through **court updation module**.
 - c. Entry User will be able to edit the details already entered in the system except case number, case type, case year party name and unique Id (given by system).
 - d. Alert generation for all cases scheduled to be heard within next 7 days and 15 days.
 - e. Anyone can get access in system through using common User Id= "reportuser" and Password= "report" to see all types of reports.

- (5) All the data from old portal has been shifted to new World Wide Web (www.ccms.gov.in) portal smoothly. As per statistics it is found that only 221 cases has been updated out of 1542 cases entered in the system. All concerned are requested to update the system upto 15/06/2016 positively.
