Reference is invited to TRAI's vacancy circular of even No. dated 12th December, 2017 filling up of the post of Senior Research Officer (Legal) in its headquarters, New Delhi on deputation on foreign service terms, initially for a period of two years. The details of eligibility criteria, qualifications and experience etc., are as under:-

Post	SENIOR RESEARCH OFFICER (LEGAL)
Pay Level:	Pay Level-11 in the Pay Matrix under 7 th CPC [Pre-revised PB-3, Rs. 15600-39100+ GP Rs. 6600] with allowances such as DA, HRA etc. as per Govt. Rules.
Eligibility criteria:	Officers of the Central Government, Central Public Sector Undertakings and Statutory and Autonomous Bodies: (i) holding equivalent post on regular basis OR (ii) Officers in Junior Time Scale with 4 years of regular service in that grade OR 7 years of regular service in the grade of Section Officer OR any other equivalent or higher grade. The officer must possess the working knowledge of computer.
Qualification:	Essential: A Degree in Law from a recognized University. Desirable: Master Degree in Law from a recognized University. The applicant should be proficient in legal/legislative drafting and should have at least 3 to 5 years experience in drafting primary or subordinate legislations and should have adequate knowledge/understanding of regulatory laws and regulatory regime governing telecommunication/broadcasting and cable services sector in India.

2. The appointment will be made on deputation on foreign service terms and will be governed by the instructions issued by the DoP&Trg. OM No. 6/8/2009-Estt. (Pay II) dated 17th June, 2010, as amended from time to time. The maximum age limit for appointment on deputation basis shall in no case exceed 56 years on the date of closing of applications in TRAI.
