CCA, Hyderabad" payable at Hyderabad or Registration certificate issued by NSIC/MSME for exemption has to be submitted offline (Scanned copy of DD/PO/exemption certificate to be uploaded online) towards tender document fee failing which the tender bid will be rejected.
