Sub: Appeal against the reply of CPIO under the clause 19 (1) of RTI Act 2005 -reg.

I have sent an application on 22.05.2018 to **the CPIO**, O/o the Controller of Communication Accounts, Department of Telecommunications, Rajasthan Circle, Jaipur, and sought for information (Copy enclosed). As the Officer Mr. D.R.Yadav is working as Sr. AO at DOT HQ, the reply is given by the Director (SEA) & CPIO. The reply is against the RTI Act.

It was intimated in the reply that "the sought information cannot be provided to you under sub section 1 of section 11 of RTI Act 2005 being the third party information, as Sh. D.R.Yadav, Sr.AO, DOT HQ, has requested not to give the desired information to the RTI applicant.

The above information is not come under the Section 8 (j) of RTI Act, which speaks about the exemption of personal information.

"relationship to any public activity or interest, or, which would cause unwarranted invasion of the privacy of the individual unless the Central Public Information Officer or the State Public Information Officer or the appellate authority, as the case may be, is satisfied that the larger public interest justifies the disclosure of such information:

Provided that the information which cannot be denied to the Parliament or a State Legislature shall not be denied to any person. "

Moreover, there is no clear definition to the 'larger public interest' or 'invasion of privacy'. In several judgments, the committee upholds principles of natural justice to justify instance of public good but these cannot be upheld for all decisions. It is also interesting to see what comes under the purview of 'public information'. It's a misconception if you think that you hold the right to revealing your age, birth date, place you belong to, your marks, the rank that you hold, the salary you get, the returns you file or subsequently any of this information regarding your children. As upheld in Madhulika Rastogi vs Regional Passport Office, New Delhi, on 4 February 2009, M. Rajamannar vs PIO, AC Division, Indira Gandhi National Open University on 18 February 2009 and A.V.Subrahmanyam vs BSNL, Hyderabad on 16 February 2009 — the judgments illustrate that information submitted to public authorities at any point in time whether to get admitted to school, to get a license, to pass a public services examination or even file a divorce; all qualify for access to other people because they have been knowingly submitted to the public domain. A lot of sensitive information like passport details, telephone call records and medical records that can map intimate interactions of a person's daily life can also be obtained if larger public interest is proven.

Further, it is clearly stated that under section 4 of the RTI ACT 2005, even salary particulars of the officer/official should be published in the public Domain.

All the particulars are available in the Service book of the officer. If the CPIO is not able to cull out from the service book, the copies of the pages of the service book in which the required particulars are entered may be provided.
