

**Subject: Follow up Action on NTP-2012 regarding Skill Development in Telecom Sector**

National Telecom Policy - 2012 recognises that the rapid growth in the Telecom Sector requires to be supported by an enhanced pace of human capital formation and capacity building. It envisages to put in place an integrated skill development strategy for the converged ICT sector as a whole.

2. Accordingly, in pursuance of strategy outlined for Skill Development in Chapter IV.8 of NTP-2012, an Apex Body for Skill Development in Telecom Sector has been constituted by the Minister of Communications & IT. The composition of the Apex Body is as under:



4. The mandate of the Apex Body will be to oversee and act as guiding and enabling source for all aspects related to skill development in Telecom Sector.


