NOTIFICATION

G.S.R. _____. -In exercise of the powers conferred by the proviso to Article 309 of the Constitution, the President hereby makes the following rules further to amend the Posts and Telegraphs Building Works (Group 'A') Service Rules, 1994, namely:-

1. (i) These rules may be called the Posts and Telegraphs Building Works (Group 'A') Service (Amendment) Rules, _____.

(ii) They shall come into force on the date of their publication in the Official Gazette.

2. In the Posts & Telegraphs Building Works (Group 'A') Service Rules, 1994, for Schedule VI, the following schedule shall be substituted, namely :-
