Subject: CIC's Decision on an Appeal in connection with the policy adopted by BSNL for making compassionate appointments in the matter of Appellant, Sh. Sudhansu Sekhar Patro, Berhampur, Distt. Ganjam, Odisha and Respondent, CPIO & Dy.Secy(Admn), DOT

I am to refer to CIC's decision vide File No.CIC/BS/A/2014/000645/7089 dated 27.02.2015 on the subject mentioned above.

The Appeal was disposed off with the following decision of CIC -

"The CPIO's representative stated that the information requested by the appellant in his RTI application dated 21.09.2013, as available on record was furnished vide letter 06/11/2013. He further stated that it can be seen from the appellant's 2<sup>nd</sup> appeal dated 09/03/2014 that he is questioning the weightage point system adopted by BSNL for making compassionate appointments but DOT has not given any directions and it is the BSNL Board which has approved the policy. The appellant pleaded that the respondent may be requested to forward a copy of the policy adopted by BSNL for making compassionate appointments. The CPIO's representative agreed to supply the information within 15 days from the date of receipt of this order."
