3. Details of Information

BACKGROUND:

I retired as Director (Admn.) on 31st Oct. 2012. After my retirement, I was appointed as the Inquiry Officer vide Order No.8-54/2010-Vig.II dated 2nd January, 2013 to complete the inquiry against Shri R. P. Gupta, JOT, DoT in a disciplinary case. The Inquiry Report was submitted to the CVO on 6th Nov.2013. I had requested for payment of appropriate honorarium in accordance with DOP&T OM No.142/15/2010-AVD-I dated 31st July, 2012. Though a subsequent reminder and another email was sent to JS (A), who was functioning as CVO on 12-5-2014 at that time, neither any payment has been made to me nor any reply has been received by me so far. I may, therefore, be informed of the status in this regard and furnished the following information under RTI Act, 2005:-

In the light of the above mentioned background, please provide the following information:

- 1) On which date my request for payment of the honorarium was submitted by the dealing officer.
- 2) Where is file pending at this stage.
- 3) Whether I am entitled for the honorarium under DOP&T OM dated 31st July, 2012.
- 4) If not, please provide the reasons for the same.
- 5) If yes, why my request has not been processed so far and no communication has been sent to me.
- 6) What is the time-frame for processing such requests.
- 7) The probable time by which my request would be processed and t sanction orders issued.
