OFFICE MEMORANDUM

Subject: Calling of Option for Absorption of Group A officers of various services in MTNL/BSNL

Reference is invited to this Department's following letters:-



Department of Telecommunications' response i.e. clarifications to the points raised in
the individual representations by Group A officers.

S.No	Points Raised	Response/Clarification
1.	It is mentioned in the option letter dated 26.8.2008 that the absorbed officers will have an option to continue in CDA pay scale till his promotion or retirement whichever is earlier. This clause is applicable from which date? Is it applicable from 1.10.2000 or actual date of absorption.	The said clause is applicable w.e.f. 1.10.2000.
2.	In the option letter dated 26.8.2008, it is mentioned that no recovery of HRA paid in the past shall be made. Whether HRA arrears, if any, will be paid.	HRA arrears becoming admissible, if any, will be paid to the absorbed officers.
3.	There should not be any upper ceiling of Special Allowance and it should also be kept out of the purview of 50% ceiling on perks and allowances as per DPE guidelines.	These ceiling have been prescribed by the Government on careful consideration of all the relevant factors.
4.	Whether option is to be exercised by the officers who have already given option for BSNL, but Presidential Order have not been issued because of pending disciplinary cases pending against the officers.	Officers who have already exercised their option for absorption in BSNL/ MTNL in the prescribed proforma by following the laid down procedure/ instructions/ prescribed last date but have not actually been absorbed because of disciplinary cases pending against them are not eligible to exercise their option afresh.
5.	If an officer does not find the absorption terms and conditions for either of the PSUs acceptable and also not like to continue in Government service, option may be made available to take voluntary retirement under Special VR Scheme of Government of India.	There is no proposal to have a Special VR Scheme as a term and condition for absorption in BSNL/MTNL. However, Group A officers who have not so far been absorbed in BSNL/ MTNL are free to seek voluntary retirement under the relevant rules/ orders of the Government of India, if eligible.
6.	In the Pension Payment Orders issued by DoT Cell, a seal is being fixed which makes a category of pensioners called "BSNL Pensioner", but there is no mention of this category in CCS (Pension) Rules, 1972. There is no clarity regarding revision of pension drawn on IDA pay scale. As in the case of BSNL, pensionary benefits including family pension are being paid by the	As per option letter dated 26.8.2008, pensionary benefits to the absorbed officers will be governed by Rule 37-A of CCS (Pension) Rules, 1972, as amended from time to time.

S.No	Points Raised	Response/Clarification
	Government and pension contribution of each employee is being made as per the provisions of FR 116, the pension revision rules as applicable to Central Government pensioners need to be clarified in respect of BSNL pensioners also.
