Subject: Appointment of Central Public Information Officers (CPIOs) and  
Departmental Appellate Authority (DAA) in the offices of Telecom  
Enforcement, Resource & Monitoring (TERM) Cells.

As per the provisions of Section 5 (1) of the Right of Information Act, 2005, the following officers in the offices of Telecom Enforcement, Resource & Monitoring (TERM) Cells, Department of Telecom are hereby designated as Central Public Information Officers (CPIOs) and Departmental Appellate Authority (DAA) to deal with cases arising under RTI Act. The officers as per designation mentioned in Annexure-I from Serial No. 1 to 34 are hereby designated as CPIOs / DAAs. Whenever the post of DDsG or Directors become vacant, the link DDG as per the list and the senior most DE/ADE, will respectively function as DDA and CPIO.

2. In case of requests involving more than one TERM Cells, the originating Cell may handle the request in co-ordination with the other TERM Cells.

3. For cases relating to policy decision or concerning the Department as a whole, the Head of office in the TERM Cell must ensure that the cases are forwarded to the CPIO in DOT headquarters within 5 days of their receipt, under intimation to the applicant.

4. The fee of Rs.10/- may be charged for applications made and additional fee for information provided as per provisions of Government of India notification No. 34012/8(S)/ 2005 (Estt. (B) dated 16.09.2005 and the receipts may be credited under the Head 1275 800-other receipts, 02- "fees on account of Right to Information Act 2005".
