Extension of Last Date till 15.02.2010 for sending applications/ documents for Appointment on Permanent Absorption basis of Group 'C' Non-Gazetted, in Department of Telecommunication (DoT) as a One Time Measure – regarding.

This Department proposes, with the approval of competent authority, to fill up the vacant posts of Group 'C' [(i) LDCs; (ii) Jr. Accountants and (iii) Sr. Accountants (all Group 'C' non-gazetted)] by appointment on permanent absorption basis as a one-time measure in the various offices of Controllers of Communication Accounts located at the places shown in *Annexure-I*.

- 2. All those persons who fulfill the eligibility conditions as prescribed in *Annexure-II* and are willing to be absorbed in DoT in the aforesaid posts, are requested to apply in the proforma enclosed *(Annexure-III)*. The application, complete in all respect and duly verified by the Head of their Parent Department/ Office, along with the requisite documents, should reach the DoT Headquarter (SEA Branch), Sanchar Bhawan, New Delhi, latest by **15.02.2010**.
- 3. The parent Department/ Office may forward the application(s), along with attested copies of ACRs for the last five years, i.e. 2004-05; 2005-06; 2006-07; 2007-08 and 2008-09, vigilance clearance certificate and a statement showing major/ minor penalties, if any imposed, during the last 10 years, to the **Under Secretary (SEA), DoT Headquarter, 716, Sanchar Bhawan, Ashoka Road, New Delhi-110 001**, so as to reach **latest by 15.02.2010**. Applications received after 15.02.2010 <u>or</u> without the requisite documents, shall not be entertained under any circumstances.
- 4. Candidates who have applied earlier for the above posts in response to this Deptt. letter of even No. dated 12.08.2009, as amended vide corrigendum of even Nos. dated 18.08.2009 and 16.09.2009 and letter dated 10.09.2009, are not required to apply afresh. The details of the applications received in response thereto have been hosted in alphabetical order on the website of the Department of Telecom., i.e. <a href="http://www.dot.gov.in">http://www.dot.gov.in</a>. All Departments concerned and individuals, who have already applied for permanent absorption for the above posts, are requested to visit the website and check for completeness of their respective applications. Any requisite document, which has still not been furnished, may now be forwarded at the address mentioned in Para 3 above so as to reach this Department latest by 15.02.2010. It may kindly be noted that inclusion of name in the above list does not entail final selection. The sole purpose of publication of this list is to inform the applicants regarding completeness of their applications.

- 5. It may please be noted that the applications shall not be considered in case the requisite documents are not received by 15.02.2010 and all applications without the following documents shall be summarily rejected:
  - i) ACRs for the last five years, i.e. 2004-05; 2005-06; 2006-07; 2007-08 and 2008-09. It has been noticed that in many cases ACR for the last year, i.e. 2008-09 has not been furnished. Hence, it may be ensured that ACR for the last year, i.e. 2008-09, is furnished;
  - ii) Vigilance certificate; and
  - iii) Statement showing major/ minor penalties, if any imposed, during the last 10 years.
- 6. In addition to the requirement as at Para 4 above, it is also stated that a few candidates have not mentioned even the choice station of posting and as such they may now intimate their choice station.
- 7. In a few cases, though the ACRs etc. have been received however, it has been noticed that their applications (*Annexure-III*) have not been received so far. Details of such cases have also been indicated on the website. The individual whose applications have not been received so far and their Departments concerned are requested to ensure that their applications (*Annexure-III*) are forwarded so as to reach latest by 15.02.2010.
