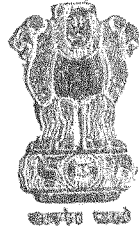

Dear Secretary,

Government of India has instituted Prime Minister's Award for Excellence in Public Administration to acknowledge the extraordinary and innovative work done by Districts and other organizations of the Central and State Governments in various areas of public governance and administration. The Prime Minister's Awards are given on the Civil Services Day (CSD) function organized by the Department of Administrative Reforms & Public Grievances (DAR&PG), Government of India in New Delhi on 21st April every year.

2. For the year 2018, the following four priority programmes have been identified for the grant of Prime Minister's Awards for Excellence in Public Administration:-

- (i) Pradhan Mantri Fasal Bima Yojana
- (ii) Promoting Digital Payments
- (iii) Pradhan Mantri Awas Yojana – Urban and Rural
- (iv) Deen Dayal Upadhyaya Grameen Kaushalya Yojana

3. In addition to Priority Programme, **two awards** will be conferred on the theme Innovations out of which one Award shall be for an Aspirational District (as identified by NITI Aayog). Under Innovation category, Central and State Government Organizations including Districts have participated for innovative work done in the field of environment conservation, disaster management, water conservation, energy, education and health, women and child centric initiatives etc.

4. To promote innovative initiatives in the policy conceptualization and implementation, **two awards** shall be considered for AS/JS & Director/DS level officers working in Government of India.

5. Accordingly, the Civil Services Day Programme will be observed this year on Saturday, 21st April, 2018. In addition, on 20th April 2018, there will be Panel discussions on various themes. All events will be held at Vigyan Bhawan, New Delhi. The details of the agenda for this year's Civil Services Day Programme as well as for the various Panel discussions will be informed in due course.

6. In the meantime, I request you to block the above dates and make it convenient to attend the function. You may also nominate all Special Secretary, Additional Secretary and Joint Secretary level officers of your Ministry/Department to participate in the Civil Services Day.
