Sir,

On the basis of final results of Engineering Services Examination-2016, the Competent Authority in Department of Telecommunications is pleased to offer you the appointment to the post of Junior Telecom Officer [CGS Group 'B'; Gazetted post] in level 7 of Rs.44900-142400 as per 7 CPC ( the Pay Band-II of `. 9300-34,800/- with the Grade Pay of `.4600/- pre revised) in the Department of Telecommunications, Ministry of Communications & Information Technology, New Delhi on provisional basis.

2. It may be mentioned that you will be on probation for a period of **two years** from the date of appointment in the Service. The Competent Authority may extend the

period of probation in accordance with the orders and instructions issued by the Government in this behalf from time to time. On your completion of the period of probation or an extension thereof, you shall, if considered fit for the service, be considered for confirmation.

- 2.1. If during the period of probation or any extension thereof, as the case may be, the Competent Authority is of the opinion that you are not fit for service, it may terminate or revert you, as the case may be, or pass such orders as it may deem fit.
- 2.2. As regards matters relating to probation, if not covered by these rules, the members of the Service shall be governed by the instructions issued from time to time by Government in this regard.
- 3. The candidates appointed to the Service (JTO of GCS Group 'B') shall be liable to serve anywhere in or outside India.
- 3.1. It may also be noted that on your appointment to the Service, if so required, you shall be liable to serve in the Territorial Army subject to the provisions of Section 6(A) of the Territorial Army Act., 1948 (56 of 1948) and the rules made there-under. Provided that such officer shall not ordinarily be required to serve as aforesaid if he/she has attained the age of forty (40) years.
- 4. It may be stated that no person
  - (a). who has entered into or contracted a marriage with a person having a spouse living, or
  - (b). who, having a spouse living, has entered into or contracted a marriage with any person

shall be eligible for appointment to the Service, provided that the Central Government / Competent Authority may, if satisfied, that such marriage is permissible under the personal law applicable to such persons and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

- 5. In accordance with Ministry of Finance, Department of Economic Affairs Notification No.5/7/2003-ECB&PR dated 22.12.2003, new entrants to the Central Government service, who have joined on or after 01.01.2004 are covered for pension under the new restructured defined contribution pension system introduced by the Government of India vide OM No. 1(7)(2)/2003/TA/11 dated 07.01.2004 and No. 1(7)(2)/2003/TA/67-74 dated 04.02.2004, and in accordance of which you will be required to furnish particulars as in the enclosed proforma, **Annexure-I**.
- 6. In respect of matters not specified above, you will be governed by the relevant rules and orders of the Government in force from time to time generally applicable to the officers of the Central Government.

- 7. If you accept the offer of appointment on the said terms and conditions of the Service, you shall intimate the same to this office as well as to Director (Training), National Telecommunications Institute for Policy Research, Innovation and Training (NTIPRIT), Department of Telecommunications, ALTTC (Advance Level Telecom. Training Centre) Campus, Ghaziabad 201001 (Uttar Pradesh) on or before 27.11.2017. While sending your letter of acceptance, it may please be intimated to this Department whether you are serving or under the obligation to service under Central Government / State Government or a Public Authority and are under any bond obligation for the same.
- 8. In case you accept the offer, you are requested to <u>report for training</u> to the Director (Training), National Telecommunications Institute for Policy Research, Innovation and Training (NTIPRIT), Department of Telecommunications, ALTTC (Advance Level Telecom. Training Centre) Campus, Ghaziabad 201001 (Uttar Pradesh) on <u>27<sup>th</sup> November, 2017 [Monday]</u> [Contact Officer Shri H. S. Jakhar, Director (Training) (Tele No. 0120-2707370/Fax No. 0120-2707371)]. In case you fail to report for duty on the scheduled date i.e., <u>27.11.2017</u> the offer of appointment will be liable to be treated as cancelled.
- 9. It may be noted that during the training period long leave will not normally be granted except in most compelling circumstances. Further, it is intimated that only single hostel accommodation is available at the training centre. You are, therefore, advised not to bring your family along with you.
- 10. Your appointment to the post of JTO of GCS Group 'B' will further be subject to :-
  - (a). The submission of a declaration in the form enclosed, **Annexure-II**, with regard to your marital status.
  - (b). The furnishing of information in respect of close relatives in the enclosed proforma, **Annexure-III**. Any change in the particulars given in the proforma should be furnished at the end of each year.
  - (c). Taking of an oath of allegiance/faithfulness to the Constitution of India and making a solemn affirmation to the effect in the prescribed form, **Annexure-IV**. The oath of allegiance/faithfulness to the Constitution of India will be provided to you at the time of reporting for joining.
  - (d). The castes/tribes certificates are being verified, through proper channels, and if the verification reveals that the claim to belong to Other Backward Classes/Scheduled Castes/Scheduled Tribes, as the case may be, is false, your services will be terminated forthwith without assigning any reasons and without prejudice to such further action as may be taken under the provisions of the Indian Penal Code for production of false certificates.

- 11. The appointment i.r.o. Shri Aditya Praklash Pandey is provisional subject to verification of your B.E. Degree for onward submission to UPSC for geeting clearance of his candidature failing which appointment letter may be cancelled.
