On the basis of the results of the Engineering Services Examination-2016 held by Union Public Service Commission for recruitment to various Engineering Services under Government of India, the President is pleased to <u>offer</u> you <u>appointment to the post of Assistant Divisional Engineer Telecom</u> (ITS) Group 'A' in the Level 10 in the scale of pay of Rs. 56100-177500 +allowances of pay matrix of 7th Central Pay Commission in the Department of Telecommunications, Ministry of Communications & Information Technology, New Delhi on provisional basis.

- 2.1. It may be mentioned that you will be in the grade of Junior Time Scale (JTS) of Indian Telecommunications Service on probation for a period of **two years** from the date of appointment in the Service. The Competent Authority may extend the period of probation in accordance with the orders and instructions issued by the Government in this behalf from time to time. On your completion of the period of probation or an extension thereof, you shall, if considered fit for the service, be considered for confirmation.
- 2.2. If during the period of probation or any extension thereof, as the case may be, the Competent Authority is of the opinion that you are not fit for service, it may terminate or revert you, as the case may be, or pass such orders as it may deem fit.
