**29719/2024** (filed by Plaintiff under Order VI Rule 17 r/w Section 151 CPC  
for amendment of plaint)

1. The Plaintiff has filed the instant suit seeking permanent injunction for protecting their copyright over the website [www.gripinvest.in](http://www.gripinvest.in).
2. At the time of filing of the suit, the Plaintiff was aware of two infringing websites, details whereof were set out in the plaint. On 19<sup>th</sup> July,

2023, on an application under Order XXXIX Rules 1 and 2 of the Code of Civil Procedure, 1908 (CPC), the Court granted an *ex-parte ad-interim* injunction in favour of the Plaintiff. Pursuant to the said order, the infringing websites were blocked and are no longer accessible.

3. Thereafter, upon the Plaintiff discovering further infringing websites, they approached the Court seeking impleadment of such websites as well as their Domain Name Registrars (DNRs). Through order dated 30<sup>th</sup> October, 2023, the said parties were impleaded and the injunction order was extended to apply to them as well. Accordingly, the said infringing websites were also blocked and are no longer accessible.

4. By way of the instant applications, the Plaintiff claims to have discovered yet another infringing website, i.e. 'https://www.eliteedgebrokerage.info'. It is contended that the said website is an exact mirror copy of the Plaintiff's website, and infringes on their trademark and copyright.

5. In view of the aforementioned background, through I.A. 29717/2024, the Plaintiff seeks to implead the infringing website, i.e. www.eliteedgebrokerage.info as 'Defendant No. 11'. Further, in order to effectively implement the Court's orders, the Plaintiff also seeks to implead the Department of Telecommunication (DoT), Ministry of Communications and IT, as Defendant No. 12. Additionally, through I.A. 29719/2024, the Plaintiff seeks to introduce the necessary amendments in the plaint in respect of the proposed Defendants.

6. Having considered the above, the Court is of the opinion that the above-captioned applications are necessary for the effective adjudication of the suit. Accordingly, the applications are allowed.



7. Plaintiff is directed to file amended of parties within a period of one week from today.
8. The amended plaint annexed with I.A. 29719/2024 is taken on record.
9. With the above directions, the applications are disposed of.

10. Upon filing of process fee, issue summons to the newly impleaded Defendants No. 11 & 12, by all permissible modes. Summons shall state that the written statement(s) shall be filed by the Defendant Nos. 11 & 12 within 30 days from the date of receipt of summons. Along with the written statement(s), the Defendants No. 11 & 12 shall also file affidavit(s) of admission/denial of the documents of the Plaintiff, without which the written statement(s) shall not be taken on record.
11. Liberty is given to the Plaintiff to file replication(s) within 15 days of the receipt of the written statement(s). Along with the replication(s), if any, filed by the Plaintiff, affidavit(s) of admission/denial of documents of the Defendants No. 11 & 12, be filed by the Plaintiff, without which the replication(s) shall not be taken on record. If any of the parties wish to seek inspection of any documents, the same shall be sought and given within the timelines.
12. List before the Joint Registrar for marking of exhibits on 8<sup>th</sup> August, 2024. It is made clear that any party unjustifiably denying documents would be liable to be burdened with costs.
13. List before Court for framing of issues thereafter.

14. By way of this application, the Plaintiff seeks an interim injunction against the newly impleaded Defendant No. 11, who is alleged to be infringing the Plaintiff’s copyright in their website [www.gripinvest.in](http://www.gripinvest.in) as



well as their registered trademark “GRIP”. A comparison of the screenshots of Defendant No. 11’s website, [www.eliteedgebrokerage.info](http://www.eliteedgebrokerage.info), with the homepage of the Plaintiff’s website is represented as follows:

<p>A comparison of the first screenshot makes it clear that the infringing website uses the same text as the Plaintiff’s Website, i.e.,</p> <p><i>“We are committed to making the financial products more inclusive. Curated Opportunity – unique investment opportunities qualified through reputed partners rigorous due diligence” Transparent focused – in depth information for each opportunity’s investment highlights and risks, commercial terms, returns and partner profile Data and Technology drive – data driven decision making with relentless dedication towards utilization of latest technology to provide a seamless investor experience”</i></p> <p>Thereafter, the infringing website uses substantially similar text as the Plaintiff’s website, i.e., <i>“find some great opportunities at Grip”</i>. The only difference being that the infringing website substitutes the word “Grip” with “Eliteedgebrokerage”.</p>	
	
<p>Even in the second screenshot, the infringing website uses the same text as the Plaintiff’s Website, i.e.,</p> <p><i>“It is really simply with Grip. 01. Explore curated investment opportunities process</i></p>	



15. From the above comparison, it is clear that Defendant No. 11's website has the same look, colour and feel as the Plaintiff's website, including the colour scheme and placement of icons and tabs. Further, the impugned website has also copied the text used in the Plaintiff's website, including their testimonials.

16. In view of the above, the Plaintiff has made out a *prima facie* case for grant of interim injunction; balance of convenience also lies in favour of the Plaintiff and irreparable loss would be caused in case the Defendants are not enjoined from carrying out their infringing activities.

17. Accordingly, till the next date of hearing, the following directions are issued:

17.1. Defendant No. 11 and/or anybody acting on their behalf is restrained from operating the domain 'eliteedgebrokerage.info', as well as the website to which the said domain name resolves.

17.2. Defendant No. 4 (NameSilo LLC), the Domain Name Registrar of Defendant No. 11's impugned website, is directed to lock and suspend the website resolving on the domain name 'eliteedgebrokerage.info'. Further, they shall file in a sealed cover the necessary information pertaining to the identity of registrant(s) of the said domain name, as is available with them, within a period of four weeks from today.

17.3. Defendants No. 2 (MeitY) and 12 (DoT) are directed to issue necessary notifications/ directions to telecom service providers and internet service providers in India, to block/ remove access to the website 'www.eliteedgebrokerage.info'.

18. Compliance of Order XXXIX Rule 3 of CPC be done within a period of one week from today. Considering the particular facts of the case,



compliance *via* email is permitted.

19. Issue notice to Defendants No. 11 & 12, by all permissible modes, upon filing of process fee, returnable on the next date of hearing. Reply, if any, be filed within a period of four weeks form the date of service. Rejoinder thereto, if any, be filed within a period of two weeks thereafter.

20. Re-notify on the date already fixed i.e., 5<sup>th</sup> September, 2024.
