**CORAM:**  
**HON'BLE MS. JUSTICE MINI PUSHKARNA**

**ORDER**

% **23.08.2024**

1. The present suit has been filed seeking permanent injunction restraining the defendants from making available to the public, any content which results in the infringement of the exclusive broadcasting reproduction rights of the plaintiff for the territory of India, across multiple tournaments and matches from various third parties.

2. The details of the agreements, which are still subsisting in favour of the plaintiff, are as follows:

I. Agreement with Cricket West Indies, Inc. (CWI), which is till 31<sup>st</sup> December, 2024.

II. Agreement with European Cricket League AG (ECL AG), which agreement is till 31<sup>st</sup> December, 2029.

III. Agreement with New Zealand Cricket (Incorporated), which is till



2026.

IV. Agreement with Malaysian Cricket Association, which is till 31<sup>st</sup> December, 2024.

V. Agreement with Afghanistan Cricket Board, which is till 31<sup>st</sup> December, 2027.

VI. Agreement with European Cricket League AG, which grants to the plaintiff exclusive rights to broadcast cricket matches from the European Cricket Championship, which is till 31<sup>st</sup> December, 2029.

VII. Agreement with Cricket Ireland for grant of broadcasting rights in Cricket Ireland's domestic competitions, which is till 31<sup>st</sup> December, 2026.

VIII. Broadcast license for Cricket Hong Kong in relation to domestic and international cricket matches organized by Cricket Hong Kong, which is till 30<sup>th</sup> November, 2026.

IX. Agreement with Pitch International LLP, granting to the plaintiff broadcasting rights in International Women's matches organized by Cricket Ireland in Ireland, which agreement is till 31<sup>st</sup> August, 2026.

3. Learned counsel appearing for the plaintiff submits that initially the present suit was filed against the defendant nos. 1 to 26. Subsequently, upon application filed by the plaintiff vide order dated 14<sup>th</sup> September, 2022, defendant nos. 50 to 147 were impleaded.

4. Attention of this Court has been drawn to order dated 14<sup>th</sup> July, 2022, wherein, all the defendants were restrained from telecasting, broadcasting, streaming, or in any manner making available to the public any of the events covered by the plaintiff. The order dated 14<sup>th</sup> July, 2022 was extended to defendant nos. 50 to 147 vide order dated 14<sup>th</sup> September, 2022.

5. Learned counsel appearing for the plaintiff submits that plaintiff is the



proprietor of multi-sport aggregator platform called FanCode, through which the plaintiff offers content, merchandise and community engagement. The plaintiff's FanCode platform streams variety of live sporting matches and events for which exclusive broadcasting rights have been acquired by the plaintiff by entering into various agreements with third parties, as noted herein above.

6. The present suit was filed, since in March, 2022, the plaintiff came across large number of websites and mobile applications, which were illegally re-broadcasting/re-communicating and telecasting the live streaming of the Cricket events, in which the exclusive rights belonged to the plaintiff as per the agreements.

7. Learned counsel appearing for the plaintiff has filed fresh agreements to show that the aforesaid agreements, are still subsisting, in favour of the plaintiff.

8. Accordingly, the following directions are issued:

I. Decree of permanent injunction is passed in favour of the plaintiff and against defendant nos. 1 to 26 and 50 to 147, thereby, restraining the said defendants, their proprietor, partners, officers, servants, employees, and all others acting for and on their behalf, or anyone claiming through them in any manner, from making available to the public, any content which results in infringements of the plaintiff's broadcast reproduction rights, as per the agreements as noted above.

II. Plaintiff is given liberty to bring to the notice of defendant nos. 40 to 48, any other third party website/URLs that may be subsequently identified by the plaintiff, as infringing its broadcast reproduction rights. In case any such other third party websites/URLs are brought to the notice of defendant



nos. 40 to 48 by the plaintiff, then, defendant nos. 40 to 48 shall proceed to permanently block access to such other website/URLs.

III. Defendant no. 49 shall issue notification calling upon the various internet and telecom service providers registered under it, to block any third party websites/URLs, that may subsequently be identified by the plaintiff, as infringing its broadcast reproduction rights.

9. Decree sheet be drawn up in terms of the aforesaid directions.

10. The suit is accordingly disposed of, along with the pending applications.

**Annexure**

Subject: Action requested to be taken by MEITY and Plaintiff for effective removal of content for viewing by public at large within India as per the said orders of Hon'ble Court.

It is observed that a number of orders of Hon'ble Court are issued for blocking of websites every month. There are around more than 2700 ISPs in India and these ISPs are connected among themselves in a mesh network. DOT is instructing each of the ISPs through emails/through its website for blocking of the websites as ordered by the Hon'ble Courts. Ensuring compliance of the orders by each of the ISPs is a time-consuming and complex task especially in view of multiplicity of orders of Hon'ble Courts, multiplicity of websites to be blocked and multiplicity of ISPs.

2. Allocation of Business Rules inter-alia states thus:-

*'Policy matters relating to information technology; Electronics; and Internet (all matters other than licensing of Internet Service Provider).'*

3. In view of above and in order to ensure effective removal by content for viewing by public at large, the plaintiff is requested to do a trace route of the web server hosting the said website. In case the web server happens to be in India, the plaintiff may inform the same to Meity who may direct the owner of such web server to stop transmission of content as per IT Act and as directed by the Hon'ble Court so that the content would be blocked from the source itself and the exercise of blocking by 2700 ISPs would not be required.

4. In case such server is located abroad i.e. outside India then access to such URL/website can be blocked through the international internet gateways which are much less in number. This would result in timely and effectively removal of undesirable content for viewing by public at large as is the requirement as per the orders of Hon'ble Court.
