## Office Memorandum

Sub: Implementation of Skill Development Initiatives under National Telecom Policy, 2012 - Registration of BSNL/ MTNL Training Centres

As per the mandate from the Apex Body on Skill Development in Telecom Sector, skill development initiatives need to be targeted at all levels of the skill pyramid – at higher skill levels to ensure industry competiveness and at lower skill levels where much of the work force is concentrated, for effective service delivery and service utilization. The Apex body had also decided that BSNL/ MTNL which have extensive and capital intensive state-of-the-art training infrastructure will need to play a pivotal role in catering to the higher skill levels where exposure to the back-end equipment will be a must.

- Further, as per para 8.2 of the National Telecom Policy, National Telecom Institute for Policy Research, Innovation and Training (NTIPRIT) is to be strengthened and developed as an institute of international repute, for capacity building and enabling research in India centric technologies and policies in telecom domain. The Institute has already been instrumental in capacity building in the Telecom domain, which needs to be taken further so that NTIPRIT spearheads the Government initiatives for Skill Development in the Telecom Sector.
- In view of the above it was considered appropriate that, to begin with, the training centres of BSNL/ MTNL may be registered with NTIPRIT to provide the initial momentum to the Skill building initiatives in the Telecom Sector. Accordingly, a committee under NTIPRIT, with participation of nodal officers from BSNL and MTNL, was constituted to recommend the modalities for registration of training institutes of BSNL/ MTNL for Skill development initiatives under NTIPRIT. The committee has since submitted its report providing a way forward in this direction.
- 4. The recommendations of the committee have been considered, and the following approval of competent authority is hereby conveyed:
- 4.1 The following training centres of BSNL/ MTNL may be registered under the skill-building initiatives being spearheaded by NTIPRIT:
  - (a) Seventeen premier Telecom Training Centres of BSNL which are spear-heading BSNL skilling initiatives.
  - (b) Institute of Telecom Technology and Management, MTNL, Delhi
  - (c) Centre for Excellence in Telecom Technology and Management, MTNL, Mumbai A consolidated list of these 19 training centres is at Annex A.
- 4.2 More training centres may be considered for registration as the ecosystem evolves.
- 4.3 These training centres will function as premier Institutions at State/ Regional level under the aegis of NTIPRIT and will play a lead role in the decentralization of Government's Skill-building initiatives. They will also act as DoT's Points-of-Presence for skilling initiatives at regional level.

- 4.4 The selected training centres may start offering courses recognized by NTIPRIT. NTIPRIT will help in developing pool of Subject-matter experts to bring uniformity in curriculum, reading materials etc.
- NTIPRIT and these Training Centres shall jointly workout appropriate delivery mechanism.
- 6. This office may be kept updated on the progress made in this regard.
