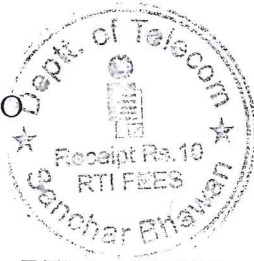

Provide the copies of the note sheets and orders wherein the Recruitment Rule for the AAO (after merging the accounts cadre of Dept. of Posts & Dept. of Telecommunications for Group 'B' Gazetted level) has been approved by the competent authority. Provide the copy of Recruitment Rule, If not framed, kindly provide reason for the same.
