Following transfer and posting in the Higher Administrative Grade of the Indian P & T Accounts and Finance Service Group 'A' is ordered with immediate effect:-


2. Ms. Nirmala Pillai [Staff No.80023], on her return from leave, is hereby posted as Pr. CCA, Delhi.

Vide 6/N Hon'ble MOC&IT has approved posting of Ms. Nirmala Pillai as Pr. CCA, Delhi on return from leave and accordingly orders are being issued. Meanwhile the Officer has sought extension of leave till 15 August, 2012.

2. The proposal for creation of HAG/SAG posts in DOT HQrs which was submitted for Cabinet approval after due approval by the Finance Ministry, has been returned for providing further details. The reply is under preparation. It has become necessary to augment the manpower resources at HQrs in view of certain important items of work not getting the required attention on account of the existing DDsG already constrained by the present workload.

3. It is, therefore, proposed that the following items of work which need attention on priority be also attached to the Pr. CCA, Delhi in addition to her existing workload without any extra remuneration for a period of six months:
