The undersigned is directed to forward herewith representations of following officers for grant of Ad-hoc promotion to the grade of AAO w.e.f 26.12.2000 which are self explanatory:

2. Sh. S. N. Gupta, AO (Staff No. 89958) Rajasthan Circle
3. Sh. Balaant Kumar, JAO (Retd.) Jharkhand Circle
4. Sh. Anil Kumar, AO (Staff No. 180533) UTL Circle

The above cases have been referred many times to DOT in which DOT has taken a stand that since these officers have been absorbed in BSNL w.e.f 01.10.2000, hence the issue of further promotion to the grade of AAO w.e.f 26.12.2000 is to be settled by BSNL.

In this connection, following is submitted:


1. These officers though were absorbed in BSNL w.e.f 01.10.2000 but they were not BSNL Recruits but promoted as JAO in DOT era.
2. The Ad-hoc promotion to AAO order dated 26.12.2000 was issued by DOT immediately after formation of BSNL and all the work related to DPC was done by DOT and all the relevant files/records related to the DPC is available with DOT.
3. Thereafter regular promotion orders to the grade of AAO w.e.f 01.04.2001 and 01.04.2003 were also issued by DOT since the absorption process was not over till 2003 and as the officers up to 2003 were belonging to DOT. Thereafter, AAO was declared as wasting cadre by BSNL vide order dated 12.04.2004.
4. The reasons for non-consideration of AAO promotion from the dates requested by the executives are not known to this office in the absence of which BSNL is not in a position to comply with the direction of DOT to deal the case. Moreover, review DPC if any can be done only by the authority which has done the original DPC since all the inputs of the case are available with them only.

It is therefore, once again requested to dispose off all the representations enclosed with the letter as one time measure as done in the case of Sh. P. C. Sachan vide letter no. 8-194-SEA (Pt.) dated 27.07.2015 since BSNL is not in a position to comply with the directions of DOT for the above mentioned reasons.

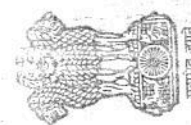
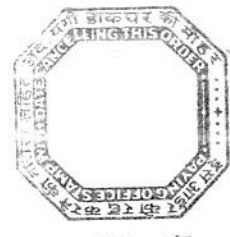
