- 1. Pursuant to the order passed on 27<sup>th</sup> November, 2024, an amended memo of parties along with amended plaint has been filed on behalf of the plaintiff.
- 2. Issue summons in the suit to the newly impleaded defendants no.12 to 17, 20, 22 through all permissible modes including e-mail and the remaining defendants no. 18, 19, 21, 23, 24 and 25 be served through e-mail.

- 3. The summons shall state that the written statement(s) shall be filed by the defendants within statutory time limits. Liberty is also given to the other defendants to file an amended written statement(s).
- 4. Liberty is given to the plaintiff to file replication(s), if any, within thirty days from the receipt of the written statement(s).
- 5. List before the Joint Registrar on 17<sup>th</sup> February, 2025 for completion of service and pleadings.
- 6. List before the Court on 28<sup>th</sup> March, 2025.

# I.A. 46351/2024 (under Order XXXIX Rules 1 and 2 CPC)

- 7. This application has been filed on behalf of the plaintiff under Order XXXIX Rules 1 and 2 of Code of Civil Procedure, 1908 ('CPC') seeking relief of injunction against the newly impleaded defendants no.12 to 25.
- 8. To be noted, *vide* Order dated 11<sup>th</sup> July, 2024, an injunction order was passed in favour of the plaintiff, restraining the defendants from using the registered trademarks of the plaintiff. Moreover, *vide* the said order, the multiple websites of the defendants that were being used to carry out fraudulent activities were directed to be suspended and blocked.
- 9. Subsequently, the plaintiff has come to know about additional websites, phone numbers, e-mail IDs and bank accounts owned and operated by defendants no.12 and 25 through which the defendants are continuing to defraud innocent customers by using the plaintiff's trademarks, logos and ad campaigns. The defendants are attempting to impersonate the brand/business of the plaintiff by using its trade name, content, products, and other intellectual property to scam potential dealers/consumers of the plaintiff.
- 10. The plaintiff has provided the details of ten victims, who were seeking a new dealership of Asian Paints in paragraph 13 of the application. The

victims, while searching online for Asian Paints dealerships, were misled by fraudulent websites using the plaintiff's trademark. The said victims were deceived by unknown parties into paying money based on false promises of the plaintiff's dealership.

- 11. The defendants no.12 and 25 are falsely claiming to be associated with the plaintiff and are fraudulently offering fake franchises /distributorships purportedly on the plaintiff's behalf.
- 12. In view of the above, the present application has been filed for freezing the bank accounts, blocking telephone numbers as well as suspending the domain names of defendants no.12 and 25.
- 13. Based on the averments made in the application and submissions advanced by the counsel, a *prima facie* case has been made out in favour of the plaintiff. Clearly, the defendants are using the plaintiff's trademarks, logos, and ad campaigns to dupe innocent customers into paying money under false promises of dealership opportunities.
- 14. Balance of convenience is in favour of the plaintiff and against the defendants. Irreparable injury would be caused to the plaintiff if the defendants continue to use the impugned marks/labels. Prejudice would also be caused to the public as the marks/labels/ad campaigns being used by the defendants are that of the plaintiff.
- 15. Consequently, the application is allowed and an *interim* injunction is passed in favour of the plaintiff till the pendency of the present suit in the following terms:
  - (a) The defendants no. 12 and 25, their employees, their employees, servants, agents, representatives and all others in active concert or participation with them are restrained from illegally using,





in any, form or manner, the plaintiff's Asian Paints trademarks or any other deceptively similar marks and/or its variants either on their websites or in any other manner.

- (b) The defendants no. 4 and 13 to 15 are directed to freeze the bank accounts associated with them as mentioned in paragraph 17 of the present application and disclose the KYC details of the owner and/or beneficiary of the said bank accounts under an affidavit.
- (c) The defendants no.9, 16 and 17 are directed to block/suspend the phone numbers mentioned in paragraph 18 of the present application and disclose the complete KYC information pertaining to the owner/operator of the said phone numbers.
- (d) The defendants no. 2, 3, and 18 to 24 are directed to suspend and lock their respective domains (during the pendency of the suit) mentioned in paragraph 19 of the present application and furnish all the information, including but not limited to the full name, address, account details and email addresses of the Registrants of their respective domains.
- (e) The defendants no. 7 and 8 are directed to issue a notification, calling upon all the internet service providers to suspend access to the websites/ domains mentioned in paragraph 19 of the present application as well as the domain asianpaints.com.br (of defendant no. 25).
- (f) The defendant no.8 is directed to issue a notification, calling upon the telecom service providers (defendants no. 9, 16 and 17) to block the phone numbers mentioned in paragraph 18 of the present

- 16. Issue notice.
- 17. Notice is accepted on behalf of defendants no. 2, 4, 7 and 8 by their respective counsel.
- 18. Notice be issued to the newly impleaded defendants no.12 to 17, 20,
- 22 through all permissible modes including e-mail and the remaining defendants no. 18, 19, 21, 23, 24 and 25 be served through e-mail.
- 19. Reply(ies) be filed within four (4) weeks.
- 20. Rejoinder(s) thereto, if any, be filed within two (2) weeks thereafter.
- 21. Compliance of Order XXXIX Rule 3 of the Code of Civil Procedure, 1908 (CPC) shall be filed within one (1) week from today.

- 10. It is submitted that the WHOIS records for the domain asianpaints.com.br did not contain any details of a Registrar, but did contain the name and email address of the Registrant, i.e., Antonio Marcos da Silva, which has been impleaded as Proposed Defendant No. 25.

## **Annexure**

Subject: Action requested to be taken by MEITY and Plantiff for effective removal of content for viewing by public at large within India as per the said orders of Hon'ble Court.

It is observed that a number of orders of Hon'ble Court are issued for blocking of websites every month. There are around more than 2700 ISPs in India and these ISPs are connected among themselves in a mesh network. DOT is instructing each of the ISPs through emails/through its website for blocking of the websites as ordered by the Hon'ble Courts. Ensuring compliance of the orders by each of the ISPs is a time-consuming and complex task especially in view of multiplicity of orders of Hon'ble Courts, multiplicity of websites to be blocked and multiplicity of ISPs.

2. Allocation of Business Rules inter-alia sates thus:-

'Policy matters relating to information technology; Electronics; and Internet (all matters other than licensing of Internet Service Provider)'.

- 3. In view of above and in order to ensure effective removal by content for viewing by public at large, the plantiff is requested to do a trace route of the web server hosting the said website. In case the web server happens to be in India, the plantiff may inform the same to Meity who may direct the owner of such web server to stop transmission of content as per IT Act and as directed by the Hon'ble Court so that the content would be blocked from the source itself and the exercise of blocking by 2700 ISPs would not be required.
- 4. In case such server is located abroad i.e. outside India then access to such URL/website can be blocked through the international internet gateways which are much less in number. This would result in timely and effectively removal of undesirable content for viewing by public at large as is the requirement as per the orders of Hon'ble Court.
