

Dy. Secretary (Coord.) & Nodal Officer (RTI), DoT vide their OM under reference (received in PSA Branch on 01.09.2015) transferred your RTI request dated 27.07.2015, which was transferred to them online (registration no. DOTEL/R/2015/80190 dated 25.08.2015) by BSNL. The information sought by you is given in subsequent paras.

2. Shri R. K. Upadhyay, CMD, TCIL was appointed as CMD, BSNL for a period of three years w.e.f. 30.04.2011. The date of birth of Shri R. K. Upadhyay was 09.06.1954. He was completing three years tenure as CMD, BSNL on 30.04.2014 i.e. prior to his date of superannuation i.e. 30.06.2014. In terms of the instructions contained in PESB's DO No. 13/07/210-PESB dated 13.05.2011, he was considered for extension of his tenure beyond 30.04.2014 till his date of superannuation i.e. 30.06.2014.

3. Public Enterprises Selection Board (PESB) in its joint appraisal meeting recommended for extension of tenure of Shri R. K. Upadhyay for the period beyond 30.04.2014 to 30.06.2014. The proposal was thereafter forwarded for consideration/approval of DoPT (ACC). During the pendency of said proposal, the tenure of Shri R. K. Upadhyay as CMD, BSNL was extended vide order dated 06.05.2014 (**Annex.A**) for a period of one month beyond 30.04.2014 or until further receipt of orders from ACC, whichever is earlier.

4. DoPT vide their communication dated 03.06.2014 conveyed the approval of Appointments Committee of the Cabinet (ACC) for extension of tenure of Shri R. K. Upadhyay, CMD, BSNL beyond 30.04.2014 till 30.06.2014 i.e. the date of his superannuation on attaining the age of 60 years of until further orders, whichever is earlier. Pursuant to that the tenure was extended upto 30.06.2014 vide order dated 11.06.2014 (**Annex.B**).

5. Appeal if any, against the information furnished herewith may be preferred before Shri V. Umashankar, Joint Secretary (T) & Appellate Authority, Room No. 319, Deptt. of Telecommunications, Sanchar Bhawan, New Delhi within 30 days from the date of issue of this letter.
