

**1. COMPANY PROFILE:**

BBNL is a Special Purpose Vehicle (SPV), set up by the Government of India for the Establishment, Management and Operation of National Optical Fibre network (NOFN) to provide 100 mbps connectivity to all the 250000 Gram Panchayats (GPs) in the country. It was incorporated as a company on 25.02.2012.

Its Registered and Corporate office is at New Delhi.

The authorized and paid up capital of the Company was Rs 1000/- crore and Rs. 60/- crore respectively as on March 31, 2015.

The shareholding of the Government of India in the company is 99.994%.

**2. JOB DESCRIPTION AND RESPONSIBILITIES:**

Director (Operation) is a member of the Board of Directors and reports to Chairman & Managing Director. He is overall responsible for operations and management of the National Optical Fibre Network serving the Broadband needs of all Panchayats spread across the country and for short & long term business interests of the company including customer satisfaction.

**3. ELIGIBILITY**

**Maximum Age:** Not more than 56 years of age on the last date of receipt of application.

**Minimum Eligibility:**

Officers of the All India Services/Central Services in the Grade pay of Rs. 10,000/- and should be an engineering graduate preferably in Telecommunication/ Electrical/Electronics/Information Technology or any combination thereof. He should have technical or managerial experience in planning, execution, operation or maintenance of projects in telecom network and IT system.

**Scale of pay:** As per Government instructions for appointment on deputation.

#### **4. Duration of Appointment**

The appointment shall be for a period of 05 years from the date of assumption of charge of the incumbent or up to the date of superannuation whichever is earlier.

#### **5. SUBMISSION OF APPLICATIONS:**
