Please refer to your online request dated 25.09.2015 transferred to us vide OM under reference [recd. on 05.10.2015] and to furnish the information as under:

- (a) Copies of the noting (comprising of 8 pages)
- (b) Proposal for entrustment of additional charge of CMD, BBNL to Shri A. K. Bhargava, Director (Operation), BBNL was forwarded to DoPT (ACC) vide OM dated 21.08.2014. Thereafter, with the approval of Minister for Communications & IT additional charge was entrusted to Shri Bhargava vide order dated 28.08.2014. DoPT (ACC) vide their communication dated 26.09.2014 conveyed their approval for entrustment of additional charge to Shri Bhargava w.e.f. 01.08.2014 for a period of three months. Subsequent thereto order dated 17.10.2014 was issued.
- (c) Hon'ble MoC&IT while considering recommendation of PESB for selection of Shri P. K. Purwar, Director (F), MTNL as CMD, MTNL proposed that:
 - (i) Initiation of fresh process for appointment of CMD, MTNL for selection of the right person with the requisite qualities through Search-cum-Selection process.
 - (ii) In the interim recommended the name of Shri N. K. Yadav to ACC for entrustment of charge of the post of CMD, MTNL till a regular appointment is made.

Thereafter, proposal was forwarded for consideration of DoPT (ACC). Subsequent to the approval of the ACC, additional charge of CMD, MTNL was entrusted to Shri N. K. Yadav, Member (Services), Telecom Commission vide order dated 08.06.2015.

- (d) Copies of orders dated 28.08.2014 (1 page), DoPT (ACC) communication dated 26.09.2014 (1 page) and order dated 17.10.2014 (1 page) with regard to entrustment of additional charge of CMD, BBNL and order dated 08.06.2015 (1 page) with regard to entrustment of additional charge of CMD, MTNL.
