6. Submission of tenders: Tenders have to be submitted only online at https://eprocure.gov.in in two bid systems i.e. (i) technical bid and (ii) financial bid in the prescribed proforma. All the documents in support of eligibility criteria etc. are also to be scanned and uploaded along with the tender documents. Tender sent by any other mode will not be accepted. The list of documents to be submitted along with technical bid or envelope are detailed in Section-III under clauses 4.1 and 4.2.

7. EMD of Rs.20,000 (Rs. Twenty thousand only) in the form of account payee DD/Banker's Cheque in favour of AO (Cash), office of the CCA, Karnataka Telecom Circle, Bangalore has to be submitted by the participating tenderers. The DD has to be submitted offline before 1500 hrs on 29/03/2016 and scanned copy of DD is to be uploaded online along with other tender documents.
