**CIRCULAR**

**Sub: Provision of Residential service FTTH connection under FTTH Unlimited Broadband Plan for officers of level of JAG and above in DoT -regarding.**

This is in continuation to Circular No. 3-1/2013-PHP dated 12.02.2013 on guidelines on provision of Office Service Telecom facilities and Residential Service telecom facilities for officers/officials of DoT and Circular No. 2-2/2015-PHP dated 01.09.2015 regarding provision of residential FTTH service connection under FTTH unlimited broadband plan "FTTH 1290" for officers of level of Member and above in DoT.

2. In this connection, it is to convey that the following residential service FTTH Broadband plan has been sanctioned for the officers of the level of JAG and above upto the level of Advisors in DoT:

**For JAG level officers and above upto the level of Advisors:** Residential service FTTH broadband connection under "FTTH unlimited 1200 plan" @ 20Mbps speed upto fair usage limit [45 GB total data usage (download+upload)] and @ 2Mbps afterwards, wherever technically feasible, in place of residential broadband connection on RSTC (copper).

3. Where FTTH is technically not feasible, residential broadband connection with unlimited data download @ 4Mbps upto 20 GB and @ 512 Kbps afterwards be provided on RSTC(copper), for officers of level of JAG and above of DoT.

4. All earlier sanctions issued in respect of Broadband connection for JAG level officers and above upto the level of Advisors in DoT stands modified as per above plan.
