The RTI Act allows the Public Authority to only furnish the Information which is available and existing in physical form and as per this Act, the Public authority does not require to create any information for furnishing the same. Moreover the information sought for is not clear and specific. Therefore no information can be provided.
7	If no then it is correct that the amount was disallowed/deducted in LTC bill only by the concerned finance cell of DoT, BSNL, MTNL instead of directly disallowed/deducted by Counter signing/approving/sanctioning Authority.
