सा.का.नि. 238(अ).—राष्ट्रपति, संविधान के अनुच्छेद 309 के परन्तुक द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए और बेतार आयोजना और समन्वय तथा अनुश्रवण संगठन (बेतार सलाहकार) भर्ती नियम, 2003, संचार और सूचना प्रौद्योगिकी मंत्रालय, दूरसंचार विभाग, बेतार आयोजना और समन्वय तथा अनुश्रवण संगठन [संयुक्त बेतार सलाहकार या निदेशक (बेतार अनुश्रवण)] भर्ती नियम, 2003, बेतार आयोजना और समन्वय तथा अनुश्रवण संगठन (तकनीकी अधिकारी और कर्मचारिवृंद) भर्ती नियम, 1960, बेतार आयोजना और समन्वय तथा अनुश्रवण संगठन (सहायक बेतार सलाहकार/प्रभारी इंजीनियर) भर्ती नियम, 2003, बेतार आयोजना और समन्वय तथा अनुश्रवण संगठन (इंजीनियर) भर्ती नियम, 2002, को उन बातों के सिवाय अधिक्रांत करते हुए, जिन्हें ऐसे अधिक्रमण से पूर्व किया गया है या करने का लोप किया गया है, भारतीय रेडियो विनियामक सेवा, संगठित तकनीकी समूह 'क' केंद्रीय सेवा की भर्ती की पद्धति का विनियमन करने के लिए निम्नलिखित नियम बनाते हैं, अर्थात्:—

1. संक्षिप्त नाम और प्रारंभ—(1) इन नियमों का संक्षिप्त नाम भारतीय रेडियो विनियामक (समूह 'क') सेवा नियम, 2015 है।

(2) ये राजपत्र में प्रकाशन की तारीख को प्रवृत्त होंगे।

2. परिभाषाएं— इन नियमों में, जब तक संदर्भ से अन्यथा अपेक्षित न हो,—

(क) "आयोग" से संघ लोक सेवा आयोग अभिप्रेत है ;

(ख) "नियंत्रक प्राधिकारी" से संचार और सूचना प्रौद्योगिकी मंत्रालय के माध्यम से केंद्रीय सरकार अभिप्रेत है ;

(ग) "विभागीय प्रोन्नति समिति" से इन नियमों की अनुसूची 4 के अनुसार गठित किसी श्रेणी में अधिकारियों की प्रोन्नति पर विचार करने के लिए समिति अभिप्रेत है ;

(घ) "विभागीय पुष्टि समिति" से इन नियमों की अनुसूची 4 के अनुसार गठित कनिष्ठ समय वेतनमान श्रेणी में अधिकारियों की पुष्टि पर विचार करने के लिए समिति अभिप्रेत है ;

(v) who having a spouse living, has entered into or contracted a marriage with any person,

shall be eligible for appointment to the Service:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such persons and the other party to the marriage and that there are other grounds for doing so, exempt any person from the operations of this rule.

15. Power to relax.- Where the Government is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing and in consultation with the Commission, relax any of the provisions of these rules with respect to any class or category of persons.

#### SCHEDULE-II

##### Qualification and Age for Direct Recruitment

1. The minimum educational qualifications and age limit for direct recruitment to the posts in Group 'A' Junior Time Scale of the Indian Radio Regulatory (Group 'A') Service, on the basis of the Combined Competitive Engineering Services Examination conducted by the Commission shall be -

(A) A candidate shall possess -

- (i) Degree of a recognised University in Telecommunication Engineering or Electrical Engineering with Radio Communication or Electronics or Telecommunication as a special subject; or
- (ii) Master's Degree in Science with Physics and Radio Communication or Electronics or Telecommunication as a special subject; or
- (iii) M.Sc. degree or its equivalent with Wireless Communication, Electronics, Radio Physics or Radio Engineering as a subject; or
