SECTION - I

GENERAL (COMMERCIAL) CONDITIONS

1.1. Specifications for the vehicles :

The bidders should have at least one light commercial vehicle such as swift Dzire/Indigo or equivalent or higher version (One A/C & One Non A/C) of model not older than 2014, registered in the name of proprietor/partners of the firm and should have registered commercial vehicle at the time of Bid submission, not having initial odometer reading more than 50,000 Kilometers and having Interstate Transit permission for Assam and Meghalaya and Arunachal Pradesh, from the prospective contractors who can supply Commercial VEHICLES for TERM Cell Assam, DoT.

1.2. Eligibility Conditions

- a) The bidder should have at least one year experience of supplying commercial vehicles in last three years. Certificate of satisfactory performance in supplying commercial vehicle should be attached with the bid. Preferably from Central Govt./State Govt./Public sector/Reputed private sector.
 b) The bidder should have at least one light commercial Vehicle

 c) The bidder shall submit a clear declaration that the firm will

- d) The bidder shall be registered for service Tax, Income Tax.

- b. The bidder shall furnish the particulars of the past performance with supporting documents (at least one year experience of supplying commercial vehicles in last three years).
- c. Declaration that firm shall be able to supply two commercial vehicles as specified in para 1.1.
- d. Bid Security of required amount in form of Demand Draft/Bank Guarantee.
- d. Valid Service TAX Registration Certificate.
- e. Latest Income TAX return (AY 2015-16) submitted along with copy of PAN card.
- f. Incorporation Certificate of Company/Firm as applicable below:

Failure to furnish all the information required as per Bid Documents or submission of the bids not substantially responsive to the Bid Documents in every respect may result in rejection of the Bid. All the certificates shall be duly signed by the bidder failing which may result in rejection of the Bid.

B. Financial Bid

Envelope should contain Section IV of the tender document properly filled in, signed and stamped.

1.4. Packing Bid Documents:

a) Tender should be submitted in **two covers**; <u>One</u> super scribing "Technical Bid" and <u>Second</u> "Financial Bid" and both the envelopes are in turn be put in another envelope and this envelope should be superscripted prominently as "TENDER FOR HIRING OF COMMERCIAL VEHICLES". All the three envelopes are to be duly sealed. Technical Bid and Financial Bid shall be opened separately. No indication of the Prices should be made in the Technical Bid. Tenders received without proper sealing are liable to be rejected.

- b) Tender will be opened in the presence of Bidders on the due date of opening i.e. 15.30 Hrs on 16/09/2016. Only Technical Bids of the Tenders received will be opened on that day. The Time, Date and Venue of the opening of FINANCIAL BIDS <u>will</u> be intimated only to those Bidders, whose Technical Bid is accepted after evaluation of details and documents furnished in **Technical Bids Form**. No correspondence in this regard will be entertained. Incomplete Tender or Tender in which both technical Bid and Financial Bid are found in the same envelope is liable to be rejected. All Columns should be furnished with relevant details and no column should be left blank.

c) Financial Bid of the selected bidders only will be opened.
d) Bidder shall furnish the documents as per **Technical Bid Form**.
e) Rates should be quoted as per the schedule of Rates at Section IV and should be enclosed to **Financial Bid Form**. The format of Financial Bid Form should not be changed in any manner. Addition/ deletion/ alteration of the text will automatically render the tender invalid and therefore, will be summarily rejected.

Prescribed Format 1.5.

Tender offers shall be submitted in the prescribed format along with the original tender document and enclosed Price bid. Price bids offers not adhering to the prescribed format are liable to be rejected summarily.

Bid Price 1.6.

The supplier shall quote in original price schedule attached along with bid document for type of vehicle services given in the "Services to be provided". I.

Rate quoted in any other format /sheet will not be considered. Rate should be quoted in enclosed sheet in English figures & words without any overwriting, corrections, errors, omissions etc. Any corrections in bid or rate sheet is required to be signed by the bidder otherwise tender may be rejected II. signed by summarily.

III. The price quoted by the bidder shall remain fixed during the entire period of the contract and shall not be subject to variation on any account. A bid submitted with an adjustable price quotation will be treated as non-responsive and rejected.

Discounts or extra charges, if any mentioned by the bidders shall not be considered unless these are specifically IV. indicated in the price schedule.

Bid Security (EMD) 1.7.

- The bidder must deposit Rs 14,400/- (Rupees Fourteen Thousand four hundred only) as Bid Security (Non-Interest Bearing). The Bid Security shall be in the form of Bank Guarantee/DD from any nationalized bank payable at Guwahati in favour of CAO, O/O CCA, Assam Telecom Circle valid for 90 days from the date of tender opening.
- ii. The successful bidder's bid security will be discharged/refunded the bidder's acceptance of the award of contract satisfactorily in accordance with para 1.11 of Section I and after furnishing the performance security.

The bid security may be forfeited iii.

a) If the bidder withdraws his bid during the period of validity

specified by the bidder in the bid form.
b) If the successful bidder fails to sign contract within a week excluding Sundays and national holidays of the issue of letter

c) If the successful bidder fails to furnish performance security

in accordance with para 1.11 of Section I.

- d) A bid not secured in accordance with clause 5 shall be rejected by the DDG (TERM), Assam as non-responsive and returned to the bidder.
- The bid security of the unsuccessful bidder will be discharged/ returned as early as possible, but not later than 30 days after the expiry of the period of bid validity.

Submission of Bid: 1.8.

The bids should be duly sealed and addressed to ADG(TERM) O/O DDG, TERM Cell, Assam, and dropped in the Tender Box provided in the O/o DDG, TERM Cell, Assam, 9th Floor, BSNL Bhawan, Pan Bazar, Guwahati, Assam 781001, on or before 15:00 hours of the due date i.e. 16/09/2016.

Any bid received after the specified time and date for submission of hids shall be rejected and returned to the hidden.

1.9. Tender Opening

- The bids shall be opened in the presence of the bidder or their authorized Representative who wish to be present at the time of opening of bids on due date at their own cost. Letter of authorization for attending bid opening by representative by representative Cell, Assam on or (Annexure IV) should reach O/o DDG, TERM Cell, Assam on or before the tender opening date i.e. 15:30Hrs 16/09/2016 or shall be carried by representative on the bid opening date.
- In case the date fixed for the opening of the bids is declared as holiday by the Government of India, the revised schedule will be notified. However, in the absence of such notification, bids will be opened on the next working day, time and venue remaining unaltered.

Bid Evaluation 1.10.

a. Bids shall be evaluated to determine whether they are complete, whether any computational errors have been made, whether documents have been properly signed (all the pages should be signed) and whether bids are generally in order.
b. If there is any discrepancy between words and figures the amount

in words shall prevail.

c. TERM Cell, Assam shall evaluate in detail and compare the substantially responsive bids and comparison of bids shall be on the services offered inclusive of all the levies and charges (excluding of service tax) as indicated in the Schedule of Rates in Section IV and Evaluation of the bid as per para (e) below.

d. DDG (TERM), Assam reserves right to counter offer price against price quoted by the bidder.

1.11. Performance Security

- a. The successful bidder shall be required to deposit an amount equal to Rs.60,000/- (Rs. Sixty thousand only) within 10 days of conveying
- DDG (TERM)'s intention for accepting the bid as Performance Security. period of Performance Security is 15 Months

 b. Performance Security shall be submitted in the form of Bank Guarantee issued by a scheduled bank in the Performa provided in Annexure VI of the bid document. The Bid security of the successful bidder will be refunded upon receipt of Performance Security of correct amount and in prescribed format from the successful bidder.
- c. If the contractor fails or neglects any of his obligations under the contract it shall be lawful for DDG (TERM), Assam to forfeit either whole or any part of performance security furnished by the bidder as compensation for any loss resulting in such failure.

1.12. Award of Contract

DDG (TERM), Assam shall consider placement of letter of intent to those bidders whose offers have been found technically, commercially and financially acceptable. The bidder shall within 10 days of the issue of the letter of intent give his acceptance and sign agreement with DDG (TERM), Assam.

1.13. Right to vary Quantities

DDG (TERM), Assam reserves the right to increase or decrease the required quantity as per actual requirement in accordance with without any change in the hiring charges of the offered quantity and other terms and conditions.

1.14. Signing of Contract

Signing of Agreement shall constitute the award of hiring contract on the bidder.

1.15. Annulment of Award

Failure of the successful bidder to comply with any of the tender/contract conditions shall constitute sufficient ground for the annulment of award and forfeiture of the bid security in which event DDG (TERM), Assam may make the award to any other bidder at the discretion of DDG (TERM), Assam or call for new bids.

1.16. Right to Accept or Reject

DDG (TERM), Assam shall reserves to itself the right to accept or reject any bid or to accept whole or a portion of tender as it may deem fit, without assigning any reason.

1.17. Termination of Contract

- i. DDG (TERM), Assam may, without prejudice to any other right/remedy for breach of contract, terminate the contract in whole or in parts.
 - a. If the contractor fails to arrange the supply of any or all of the vehicle(s) within the period specified in the contract or any extension thereof granted by the DDG (TERM), Assam.
 - b. If the contractor fails to perform any other obligations under the contract Agreement.
- ii. DDG (TERM), Assam may, without prejudice to any other rights under the law or the contract provided, get the hiring done at the risk and the cost of the contractor, in the above circumstances.
- iii. Notwithstanding anything contained herein, DDG (TERM), Assam also reserves the right to terminate the contract at any time or stage during the period of contract, without assigning any reason and without incurring any financial liability to the service provider/contractor.

1.18. Termination for Insolvency

DDG (TERM), Assam may also by giving written notice and without compensation to the service provider/contractor terminate the contract if the service provider becomes unwilling, bankrupt or otherwise insolvent without affecting its right of action or remedy as hirer.

1.19. Miscellaneous Conditions:

- i. DDG (TERM), Assam reserves the right to counter offer price against price quoted by the bidder.
- ii. DDG (TERM), Assam reserves the right to disqualify such bidders for one year who fails to honour their bid.

1.20. Force Majeure

If any time, during the continuance of this contract, performance in whole or in part by either party of any obligation under this contract is prevented or delayed by reason of any war, or hostility, acts of the public enemy, civil commotion, sabotage, fires, floods, explosions, epidemics, quarantine restrictions, strikes, lockouts or act of god (hereinafter referred to as events) provided notice of happenings, of any such eventuality is given by either party to the other within 21 days from the date of occurrence thereof, neither party shall by reason of such events be entitled to terminate this contract nor shall either party have any claim for damages against the other in respect of such on performance or delay in performance under the contract shall be resumed as soon as practicable after such an event may come to an end or cease to exist, and the decision of DDG (TERM), Assam as to whether the supplies/services have been so resumed or not shall be final and conducive, provided further that if the performance in whole or part of any obligation under this contract is prevented or delayed by reason of any such event for a period exceeding 60 days either party may, at his option terminate the contract.

1.21. Arbitration

1.21.1. In the event of any question, dispute or difference arising under the agreement in connection therewith (except as to matters, the decision to which is specifically provided under agreement) the same shall be referred to arbitration of the DDG(TERM), Assam, In case his designation is changed or his office is abolished then in such case to the sole Arbitration of the officer for the time being entrusted whether in addition to the function of DDG(TERM), Assam or by whatever designation such officer may be called (herein after referred to as the said officer) and if the DDG(TERM), Assam or the said officer is unable or unwilling to act as such , than to the sole arbitration of some other person appointed by the DDG(TERM), Assam or the said officer. The agreement to appoint an arbitrator will be in accordance with the Arbitration and Conciliation Act, 1996. The adjudication of such Arbitrator shall be governed by the provisions of the Arbitration and Conciliation Act, 1996, or any statutory modification or r-enactment thereof or any rules made thereof.

- 1.21.2. The arbitrator may from time to time with the consent of both the parties extend the time frame for making and publishing the award. Subject to aforesaid Arbitration and Conciliation Act, 1996 and the rules made there under, any modification thereof for the time being in force shall be deemed to apply to the arbitration proceeding under this clause.
- 1.21.3. The venue of the arbitration proceeding shall be the office of O/o DDG (TERM), Assam at Guwahati or such other place as the arbitrator may decide.
- 1.22. **Set-Off** (Recovery of Sum Due): Any sum of money due and payable to the contractor (including security deposit refundable to him) under this contract may be appropriated by DDG (TERM), Assam and set-off the same against any claim of DDG (TERM) for payment of a sum of money arising out of this contract or under any other contract made by contractor with DDG (TERM), Assam.

1.23. Terms of Payment

Payment shall be made within 15 days from the date of receipt of bill in the O/O DDG (TERM), Assam. Monthly bills shall be submitted in duplicate to the officer-in-charge, O/O DDG (TERM), Assam, Guwahati along with the copy of the log book vehicle wise (Log Book should be duly signed by the user and the driver of the vehicle).

1.24. Duration of the Contract

Normally the contract will be awarded for One year. However, extension for the One year / part thereof will be considered on the same rates, terms and conditions.

SECTION II

SPECIAL CONDITIONS OF THE CONTRACT

- The special conditions of contract shall supplement the General (commercial)conditions of the contract as contained in Section I 2.1. and wherever there is a conflict, the provisions herein shall prevail over those in Section I.
- 2.2. DDG (TERM), Assam, reserves the right to blacklist a bidder for a suitable period in case he fails to honour his bid.
- Any liability under any Act or Statute shall be of the contractor 2.3. under no circumstances shall DDG (TERM). Assam assume responsibility.
- 2.4. The engagement and employment of drivers and payment of wages to them as per existing provisions of various labour laws and regulations is the sole responsibility of the contractor. Any breach of such laws or regulations shall be deemed to be breach of this contract.
- No sub-contracting is permissible. The bidder should have at least one Vehicle as specified in para 1.1 or the bidder should own either self or on lease minimum one Vehicles as specified in para 1.1 or shall have vehicle as specified in para 1.1 on lease 2.5. Contract with their owners.
- The near relatives of all employees working in the TERM Cell Assam, Department of Telecommunications either directly recruited 2.6. or on deputation are prohibited from participation in this tender. The near relatives for this purpose are defined as:

 I. Members of a Hindu Undivided Family;

 - They are husband and wife. II.
 - III. The one is related to the other in the manner as father, (s), son's wife(daughter- in - law), & daughter's husband (son-in-law), mother son mother son (s), son's Daughter (s) & daughter brother(s) & brother's wife, sister (s) (brother-in-law).
- The contractor shall assign the job of driving of hired vehicles to experienced drivers having appropriate license and also assume 2.7. to experienced drivers having appropriate license and also assume full responsibility for the safety and security of officers/officials as well as essential store items while running the vehicle by ensuring safe driving. DDG (TERM), Assam shall have no direct or indirect liability arising out of such negligent, rash and impetuous driving which is an offence under Section 29 of IPC and any loss caused to O/o DDG(TERM), Assam have to be suitably compensated by contractor. The contractor shall sent the vehicle for periodical servicing at the cost of the contractor. DDG(TERM).Assam will not pay any
- 2.8. the cost of the contractor, DDG(TERM), Assam will not pay any mileage run for such servicing nor any deduction be made for the duration involved in such servicing. The cost of lubricants, repairs, maintenance, taxes, insurance etc. will be to the contractor's liability.
- Regular checking of meter by the designated transport authority may be done by the contractor and requisite certificate may be 2.9.
- shown to DDG (TERM), Assam as and when demanded. Change of commercial vehicle of same type and model as specified in para 1.1 will be allowed on written request and approval of 2.10. controlling officer.
- The vehicle may be used anywhere in the territorial jurisdiction of Assam, Meghalaya And Arunachal Pradesh.
- TDS applicable will be deducted from the payable amount of the 2.12. bill.
- 2.13. The time and distance in respect of vehicles hired will commence and terminate from the time & place of reporting to the time &

place of release. For this purpose, the kilometer reading as well as the time will be recorded by the officer in the duty slip at the time of reporting and releasing the vehicle. The distance covered in each way from garage to place of reporting will be allowed on actual basis or 5 KMs whichever is less.

2.14. The contractor shall abide with all local/municipal/state/central

laws and regulations.

- 2.15. The drivers shall be provided working mobile phone at the cost of the contractor, so as to enable the officers of TERM Cell, Assam to contact them as and when required, during the period of the contract.
- Payment of all kinds of Government taxes or duties for supplying vehicles in Assam will be the liability of the contractor. 2.16.

Tampering of meter reading, vehicle usage timings overwriting of summary/log book sheets and misbehaviour by the drivers while on duty shall be viewed seriously and may lead to even cancellation of the contract at the discretion of the DDG (TERM), Assam. The Service provider/contractor shall not engage any person below the age of 18 years for driving purpose. Vehicles up-keep shall be in good condition along with good and clean Seat covers & curtains. All seat covers and curtains are to be cleaned periodically at least once in every week. Vehicles so hired may be inspected time to time by any officer of TERM, Assam authorized by DDG (TERM). Assam 2.19. authorizéd by DDG (TERM), Assam.

SECTION III

SERVICES TO BE PROVIDED

3.1. Service: Provision of commercial vehicles as specified in para 1.1 licensed drivers, on hiring basis for running in Assam including cost of fuel.

Contract Period: Under normal circumstances the contract shall be valid for a period of one year from date of signing of agreement and may be extended up to one year beyond contractual period if agreed by the contractor and the DDG (TERM), Assam on the same 3.2. rates, terms and conditions.

3.3(a)Quantity: Estimated number of vehicles to be hired is 2

it should be clearly noted that DDG (TERM), However increase or decrease the number of vehicle shall place the order only as per the actual requirement from time to time.

3.3(b) The bidder should also quote rates for hiring vehicle on daily basis as per Financial Bid item No(B) in Section IV. However these rates will not be considered while evaluating the Financial Bid.

Duty hours: Ten hours per day for six days per week. Weekly off will be given. The actual duty hours shall be specified by users of vehicles. Charges for extra duty will be provided when applicable. **Reporting Place**: Any place within the jurisdiction of the Office of DDG (TERM), Assam. Actual place of reporting shall be specified by 3.4.

3.5. users of vehicles.

Jurisdiction: Vehicle shall be required to run to any station within the territorial jurisdiction of Assam, Meghalaya and 3.6. Arunachal Pradesh

Counting of Distance: The counting of distance will be effective from the starting point of the user and closing point i.e. wherever 3.7. user completes his/ her travel. The distance covered in each way between user delivery address and the garage/normal parking place will be allowed on actual basis or 5 Kms whichever is less.

3.8. Accuracy of Meter reading: The accuracy of meter reading should tally with the actual distance of run at any instant and controlling / authorized officer shall have full power to check up the meter for its correctness and to take action to recover the actual loss to the DDG (TERM), Assam.

3.9. **Compensations:**

- In case of break down, vehicles have to be replaced by other vehicle immediately or within not more than one hour. In case of non availability of suitable vehicle as referred in General Terms and Conditions a compensation up to Rs. 500/- per occasion may be imposed in addition to deduction on pro-rata basis for the period.
