E-TENDER NOTICE

Subject: -Procurement of 01 (One) 85" LED TV for Meetings purposes in the Commission Room of DoT(Hq.), Sanchar Bhawan - regarding.

E-tender is invited on behalf of the President of India from Original Equipment Manufacturers(OEM)/ reputed Authorized vendors, having adequate experience in the relevant field, for supply and installation of 01(One) 85" LED TV of reputed brand/make for official use in the Department of Telecommunication, Sanchar Bhawan, New Delhi. Technical specification of LCD TV is mentioned at Annexure - I.

1. Instruction to the tenderers

E- tender should be submitted online through Govt. of India e tender portal [www.eprocure.gov.in/](http://www.eprocure.gov.in/) in two bid system (i) Technical Bid & (ii) Financial Bid. The Technical bid should contain full information as required in Annexure-II. The 'Financial Bid' must include full information as required in Annexure- III. Both bids described as 'QUOTATION FOR SUPPLY OF 85" LED TV' should be submitted online by 14.00 p.m. on 20.09.2016. Tender received after stipulated date/ time shall not be entertained. The tender will be opened on the same day i.e. 20.09.2016 at 14.30 p.m. The tenderer or his representative may, if they so desire, be present at the time of opening of tenders.

2. Eligibility Criteria

- (i) The supplier and the after sale service provider is located in Delhi/NCR.
- (ii) The supplier and the firm should have PAN/ TIN and VAT Number issued by concerned authority as provided in the Annexure-II.
- (iii) The supplier/ firm must submit scanned copy of tender documents with each page duly signed and stamped by the supplier/ firm or its authorized representative, in token of acceptance of all the terms & condition of tender.
- (iv) The supplier/firm should enclose a scanned copy of certificate that the LED TV make/model fulfils all the Technical specification as mentioned in Annexure. I of the tender documents.

3. Tender Fee & Earnest Money Deposit


The e-tender should be accompanied by Tender Fee Rs. 500(Rs. Five Hundred) and Earnest Money Deposit of Rs. 30,000/ (Rupees Thirty Thousand only) in the form of Account Payee Demand Draft drawn in favour of Pay & Account Officer, DOT, Sanchar Bhawan, New delhi-110001 which should be submitted off-line by 14.00 p.m. on 20.09.2016 without which the tender will not be considered. However, the scanned copies of Tender Fee and Earnest Money Deposit must be submitted on-line. The earnest money will be returned to all the unsuccessful tenderers after finalization of the tender. However, the EMD of the successful

bidder will be returned only after the successful installation / satisfactory performance of the LED TV, and while making the final payments thereof.

4. Terms and Conditions

- i. Delivery and installation of 85" LED TV within two weeks after placement of order.
- ii. The warranty period should be minimum of 03 years. Supplier/ firm should also ensure availability of spare parts during 02(Two) years after expiry of the warranty period of the LED TV make/model quoted by them
- iii. Service and repair of 85" LED TV should be done within 24 hr after complaint is made telephonically.
- iv. Telephone facility must be available with the Vendor/ Service Centre during office hours.
- v. All the charges towards repair/ servicing, any other incidental expenses on operations & maintenance of the 85" LED TV would be borne by the firm during its warranty period.
- vi. Jurisdiction for legal disputes, if any arising during the currency of the contract, will be settled in Delhi courts only.
- vii. Tenderers may please quote firm & fix rates strictly in the attached Performa, No handwritten quote in financial bid shall be accepted.
- viii. No advance payment, in any case, would be made to the firm.
- ix. The Technical Specification attached in Annexure-I should be fulfilled the vendor's machine.
- x. The EMD will stand forfeited if the successful bidder withdraws or on notifying the rates, refuses to accept the tender or violate any other terms & conditions of the tender.
- xi. Above all, performance of the 85" LED TV is the essence of the contract.
- xii. Tender would be valid 120 days from the date of opening of the e- tender. DOT reserves the right to extend the validity without assigning any reasons.
- xiii. Interested bidders should visit the actual site of installation in Sanchar Bhawan prior to submission of their bids.

5. The Department of Telecommunications reserves the right to reject or accept any or all the quotations without assigning any reason their decision of this Department in this regard shall be final and binding on the firm. Any clarification in the matter may be obtained from the undersigned.
