TRAINING CIRCULAR

Subject:- Knowledge Co-Creation Program on "Improving ICT policy promotion skills utilizing standards - overcome challenges by deployment of ICT infrastructure corresponding to the situation" in Japan from 18th January to 4th February, 2017.

The Government of Japan has invited nominations for the above mentioned training course to be held in Japan under the Technical Cooperation Programme with India. The course is intended for officers in charge of standardization of telecommunications. The eligibility conditions and other information about the course are mentioned in the Information Booklet received from the sponsoring Government (**Annex-I**). 3. **The course is sponsored by** the Government of Japan, who will provide round-trip air fare, accommodation and living allowance.


4. The following forms need to be duly completed and certified by the participant and the competent authority of the nominating Ministry/Department:
