Please refer to your RTI application dated Nil [recd. on 03.10.2016] and the requisite information is as under:


1. Shri S. Rajagopalan, an officer of Indian Telecom Service was appointed as CMD, MTNL vide Order dated 03.04.1997 (Annexure-I) for a period upto 30.05.1998 from the date of assumption of the charge.
DPE vide their OM No.18(6)/98-GM-GL-005 dated 30th May, 1998 enhanced the age of retirement of Board level appointees from 58 to 60 years w.e.f. 30.05.1998. Subsequently, vide order dated 22.06.1998 (Annexure-II), the tenure of Shri S. Rajagopalan as CMD, MTNL was extended till his age of superannuation.

This Department is not concerned with information pertaining to Shri Rajinder Singh (CMD NTPC). A copy of the request is forwarded to the CPIO, M/o Power for furnishing information directly.

2. PSA Branch has no information. However, a copy of the request is forwarded to Director (PSU-III) & CPIO, DoT for furnishing information directly.
