The list of documents to be submitted along with the technical bid or envelope and the financial bid or envelope is detailed in Section-III under clauses 4.1 and 4.2.

7. EMD of Rs.24,000 (Rs. Twenty four thousand only) in the form of account payee DD/Banker's Cheque in favour of AO (Cash), office of the CCA, Karnataka Telecom Circle, Bengaluru has to be submitted by the participating tenderers. The DD has to be submitted offline before 1500 hrs on 02.12.2016 and scanned copy of DD is to be uploaded online along with other tender documents.
