Demand Draft for an amount of Rs. 500/- (Non refundable) drawn on any Nationalized Bank payable at Jammu in favor of Accounts Officer (Cash), O/o CCA, J&K Telecom Circle. It has to be submitted before opening of bids to this office (Scanned copy of DD to be uploaded online) towards cost of tender document failing which the bid will be rejected. Bidders are requested to write their name and full address at the back of the Demand Draft.

The applicant has to deposit Earnest Money (EMD) Rs. **17,000** in form of Demand Draft drawn on any Nationalized Bank payable at Jammu in favor of Accounts Officer (Cash), O/o CCA, J&K Telecom Circle. It has to be submitted before opening of bids to this office (Scanned copy of DD to be uploaded online) towards EMD falling which the bid will be rejected. Bidders are requested to write their name and full address at the back of the Demand Draft.

The aforesaid DDs towards cost for Tender and EMD should be submitted to the tender inviting authority i.e. CCA J&K Telecom Circle, Jammu on or before the time of opening of tender.

The duly filled in tender document shall not be accepted if they are not accompanied by the scanned copy of the demand draft toward the tender fee and the requisite bid security (EMD).
