ELIGIBILITY CONDITIONS FOR APPLYING TO POSTS ON DEPUTATION IN CCA OFFICE

I. Qualification

(a) For the Post of LDC.

Officials holding same or analogous posts in various Ministries/Departments of Centre/State Govt./PSUs/BSNL on regular basis.

(b) For the post of JA (Junior Accountant)

- 1. Officials holding same or analogous posts in various Ministries/Departments of Centre/State Govt./PSUs/BSNL on regular basis, or
- 2. LDCs who have rendered not less than eight years of regular service in the grade, or
- 3. UDCs who have rendered not less than three years of regular service in the grade.

(c) For the posts of SAs(Senior Accountant)

- Officials holding same or analogous posts in various Ministries/Departments of Centre/State Govt./PSUs/BSNL on regular basis, or
- 2. JAs/Auditors who have rendered not less than three years of regular service in the grade.

(d) For the posts of AAO

- 1. Officer working under the Central Govt.
 - i. Holding analogus posts of AAO/SO (A/Cs) or regular basis or
 - ii. Junior Accounts, Clerks/Pas who have qualified in both part-I & II of JAO (Civil) SAS/SOGE or equivalent examination conducted by any of the orgainsed Accounts, Department of Central Govt.
