**Subject: Blacklisting of M/s Oceanic Technovate Pvt. Ltd.**

Undersigned is directed to say that the contract for procurement of Hardware & Software was awarded and supplied to CERT-In by M/s Oceanic Technovate Pvt. Ltd. During the processing of the case for payment of the bill it was observed that the Bank Guarantee submitted by the Vendor was not issued by the Bank.

2. The competent authority on considering all aspects and papers / documents available on record decided in accordance with the provision under Rule 151 (iii) of General Financial Rules of the Government of India to **blacklist** the Vendor who has committed a "Breach of Trust". Accordingly, M/s Oceanic Technovate Pvt. Ltd. is blacklisted by the competent authority for a period of two years effective from 21.05.2018.

3. Since the vendor has been blacklisted for 02 years the vendor or any successor of the vendor shall not be eligible to participate in a procurement process of any procuring entity for a period of two years.

4. All Ministries / Departments and Organizations under them may bring to the notice of all concerned and also include M/s Oceanic Technovate Pvt. Ltd. in the list of blacklisted firms maintained by them.
