CCA, Hyderabad" payable at Hyderabad or Registration certificate issued by NSIC/MSME for exemption has to be submitted offline (Scanned copy of DD/PO/exemption certificate to be uploaded online) towards tender document fee failing which the tender bid will be rejected. Bidders are requested to write their name and full address at the back of the Bank Draft submitted.
