NOTIFICATION

Subject: -Vacancy circular to fill up Sub Divisional Engineers (SDEs) and Junior Telecom Officers (JTOs) posts in O/o Sr. DDG, Assam LSA on deputation basis.

It is proposed to fill up the posts of Sub Divisional Engineers and Junior Telecom Officers on deputation basis from among the staff working in Central/State Government office/PSUs as per the details given below.
