Sub: - Engagement of retired personnel on short-term contract basis as consultant in the NE LSA, Department of Telecommunications.

The Office of Sr. DDG NE LSA Shillong, propose to engage retired personnel on short-term contract basis as consultant for technical work from the retired personnel from Department of Telecommunications/Posts, other Departments of Central/State Government and BSNL/MTNL/other PSUS or Research Organizations as per the terms & conditions given below:

- 1. Number of Likely vacancy (Consultants in Level 7/Level 8 of 7th CPC):-
 - Three at Shillong
 One at Arunachal Pradesh
 One at Mizoram
- 2. Eligibility: Retired from the CDA scale with substantive grade of Level 7/Level 8 of the 7th CPC or equivalent in IDA scale.
- 3. Candidates should not be more than 65 years of age on the last date of receiving the application.
- 4. Such appointment would initially be for a period of 06 months. Which, based on his/her performance, can further be extended upto maximum of 6 terms of 6 months each or 65 years of age whichever is earlier.
- 5. Computer literacy is necessary.
- 6. He should have work experience in the field of Telecommunications/IT/broadcasting.
- 7. The format of application is at Annexure 'A', the above notification is available on the office Website <u>www.dot.gov.in</u>
- 8. The consolidated fee/remuneration payable to the retired persons engaged as Consultants will be as per DOT OM no: 03-11/2016/SEA-I (Pt-1)/Fin dated: 28th December 2017 (Copy at Annexure B) and as amended from time to time. The retired official on his/her engagement as consultant may be allowed TA/DA for performing outstation duties as per his/her entitlement before retirement. The person so engaged shall not be eligible for other allowances and benefits. The payment will be made on monthly basis.
- 9. Income tax or any other tax liable to be deducted as per prevailing rules will be deducted at source before effecting the payment for which the department will issue TDS certificate. Service tax as applicable shall be payable extra as the prevailing rates.
- 10. The contract can be terminated by either of the party with prior notice of 30 days.

- 11. After scrutiny of application received, a panel will be drawn. The panel will be valid for period of 6 months. The decisions of the Department in the matter of selection of Consultants shall be final and binding upon the applicants.
- 12. The extant Terms and condition of engaging retired personnel issued by Central Government shall also applicable.
- 13. The Last date of receipt of application is 25.03.2022.
