The matter regarding implementation of new heads wef 01 Apr 2022 onwards has been discussed and deliberated at this HQ in wake of the directions issued by CGA for its implementation wef FY 2022-23 and non-inclusion of new heads of accounts in UBIS by the Department of Economic Affairs (Budget Division), MoF from which Detailed Demands for Grants are generated.

- 2. The issue has also been discussed with the O/o CGA on 24.03.2022 who has opined that due to paucity of time it would not be feasible to implement the same wef 01 Apr 2022 onwards and will be implemented from FY 2023-24 onwards.
- 3. In view of the foregoing, it is not possible for this Department to implement the revised Heads of Accounts for FY 2022-23. Hence, OM of even no. 5181-5227 dated 07/12/2021 on the subject cited above stands withdrawn.
- 4. Therefore, existing Heads of Accounts under Major Heads 1275/3275/3451/5275 shall remain active till receipt of further orders from Director (Budget), DoT (HQ).
