APPELLATE ORDER ON APPEAL DATED 27/05/2015 FILED BY SH. DEO-KRISHNA, JT. CCA, O/o PR. CCA, NEW DELHI.

I, the Appellate Authority in the Department of Telecommunications have carefully gone through the appeal dated 27/05/2015 filed by Shri Deokrishna, Jt. CCA, O/o Pr. CCA, Delhi.

Facts of the case :

- 1) Shri Deokrishna, Jt. CCA, O/o Pr. CCA Delhi sought the information in his RTI application dated 10/04/2015 regarding supply of orders delegating power to MOC &IT by the Hon'ble President of India in respect of Appointing Authority and Disciplinary Authority of Group "A" officers and a copy of order /memo alongwith notesheet approved vide which DoT has claimed to have appointed the MOS CIT as Disciplinary Authority to some grade of Group "A" officers.
- 2) Director (SEA) & CPIO has already replied of his RTI application dated 10/04/2015 received in this office on 20/04/2015 vide letter No. 33-3/2015-SEA-I(Pt.I) 13/05/2015 stating that no such information is available in SEA I Section. However, regarding information sought against point No.2, the said application was transferred to Director(VM) & CPIO and Director(Staff) & CPIO, DoT Hqrs vide letter No. 33-03/2015-SEA-I(Pt.I) dated 29/04/2015 for providing the information directly to the applicant.
3. The appellant in his appeal has stated that Director(SEA) & CPIO has not supplied copies of the requisite orders

Decision of the appeal :

In view of the above position explained above, Director(SEA) & CPIO has already replied the RTI application dated 10/04/2015 received in his office on 20/04/2015 vide his office letter No. 33-3/2015-SEA-I(Pt.I) dated 13/05/2015. Director(SEA) & CPIO has also transferred the said application to concerned CPIOs vide his letter dated 29/04/2015. They may be in better position to reply. The fact that the order of such delegation is not readily available in SEA-I section has been ascertained again.

In case you are not satisfied with the reply you may prefer IInd appeal, if any in the matter before the CIC within 90 days of issue of this order.


