Point 4:- No such information is available with this office, under the RTI Act-2005 only such information is required to be supplied which already exists and is held by or held under the control of the public authority and it is not required under the act to create information; or to interpret information; or to solve the problems raised by the applicant, or to furnish replies to hypothetical questions.
