# As per discussion during the meeting with Director(CVC), out of 44 CVC cases which are shown closing balance in the Part A. 1 of the monthly report of May, 2012, 34 cases are shown as disposed off by transferring to FI in the departmental server for further monitoring of the cases. Only the 14 cases which are shown as pending for investigation in the CVC's website are considered as pending complaints on the part of DoT. Out of the 14 cases, action has been completed on 1 complaint and 2 complaints do not pertain to Vigilance Wing, DoT (An annexure is enclosed in respect of these 3 complaints-Annexure-4).

\*\*Departmental inquiries under the CVC jurisdiction would include cases of Group 'A' Officers (Government organized services), Board Level Appointees and two levels below Board Level (PSUs) Scale V and above (PSBs and others) and composite cases where one of the Charged Officers is one of the above categories.

\*\*\*Departmental inquiries - others would include the cases of Group 'B' and 'C' categories not required to be referred to CVC.
