**I.A. 44675/2024 (O-VI Rule 17 of CPC)**

1. This application has been filed on behalf of the plaintiff under Order VI Rule 17 of the Code of Civil Procedure, 1908 seeking to amend the plaint.
2. The amendment is on account of new defendants having been added in the suit *vide* order dated 7<sup>th</sup> November, 2024 passed by the Joint Registrar.
3. Issue notice.
4. Notice is accepted by counsel for the defendants no. 7 to 9, who do not oppose the present application.

5. In my considered view, in view of new defendants (defendants 11 to 26) having been added to the suit, the proposed amendments are necessary for the proper adjudication of the present suit.

6. Accordingly, the application is allowed and the amended plaint is taken on record.

**I.A. 44673/2024 (O-XI Rule 1(5) of the CPC)**

7. By way of the present application, the plaintiff seeks leave to place on record the WHOIS details of the newly found infringing domain names and extracts of the infringing URLs, which have been subsequently discovered by the plaintiff.

8. Issue notice.

9. Notice is accepted by counsel for the defendants no. 7 to 9, who do not oppose the present application.

10. In my view, in view of new defendants (defendants 11 to 26) having been added to the suit, the aforesaid documents are necessary for the proper adjudication of the present suit.

11. Accordingly, the application is allowed and the documents are taken on record.

**I.A. 44674/2024 (O-XXXIX Rules 1 and 2 of CPC)**

12. This application has been filed on behalf of the plaintiff under Order XXXIX Rules 1 and 2 of CPC seeking to extend the *ex-parte ad interim* injunction order passed by this Court on 18<sup>th</sup> March, 2024 to the newly added defendants No. 11 to 26.

13. Since the aforesaid injunction order was passed by this Court on 18<sup>th</sup> March, 2024, the plaintiff has identified several additional domains/websites/URLs that are using the plaintiff's registered trademark



‘DASNAC’ and are also promoting, advertising and offering for sale plots within the plaintiff’s properties. The lists of these websites and URLs have been filed with the present application as documents ‘A’ and ‘B’. Further, the extracts and screenshots from these websites and URLs have been given in paragraph 12 of the present application.

14. It is the case of the plaintiff that it has not authorized any third-party to promote or offer the plaintiff’s properties for sale. The defendants no. 1 to 6 as well as the defendants no. 15 to 26 are unlawfully using the plaintiff’s registered trademark to falsely represent association with the plaintiff. Since the details of the defendants no. 15 to 26 are not known as of now, they have been impleaded as John Doe defendants and the plaintiff seeks their disclosure from the Domain Name Registrars (DNR) being the defendants no.7 and 12 to 14.

15. A *prima facie* case is made out on behalf of the plaintiff. Balance of convenience is in favour of the plaintiff and against the defendants. Irreparable injury would be caused to the plaintiff if the defendants continue to use the impugned trademark on their websites/URLs. Prejudice would also be caused to the public as the trademark of the defendants is identical to that of the plaintiff and is likely to cause confusion in the market.

16. Consequently, till the next date of hearing, the defendants no. 11 and 15 to 26, their representatives, and any others acting on their behalf are restrained from using the plaintiff’s registered DASNAC trademark or any deceptively similar variant thereof, whether as a trademark, trade name, domain name, or on any third-party website, email addresses, or in any other manner.

17. Further, the defendants no. 7 and 12 to 14 are directed to:



- (i) Disclose the complete address and contact details of the registrants of the impugned domains as listed in document A attached hereto; and
- (ii) (ii) Suspend and lock the impugned domains as listed in document A attached hereto.

18. The defendants no. 8 and 9 are directed to issue notifications to telecom and internet service providers, requiring them to suspend access to the infringing websites/URLs listed in Documents A and B attached hereto.

19. Issue notice.

20. Notice is accepted by counsel for the defendants no. 7 to 9.

21. Notice be issued to the remaining defendants *via* all permissible modes, including e-mail.

22. Reply(ies) be filed within four (4) weeks.

23. Rejoinder(s) thereto, if any, be filed within two (2) weeks thereafter.

24. List on 19<sup>th</sup> December, 2024, the date already fixed.

Subject: Action requested to be taken by MEITY and Plaintiff for effective removal of content for viewing by public at large within India as per the said orders of Hon'ble Court.

It is observed that a number of orders of Hon'ble Court are issued for blocking of websites every month. There are around more than 2700 ISPs in India and these ISPs are connected among themselves in a mesh network. DOT is instructing each of the ISPs through emails/through its website for blocking of the websites as ordered by the Hon'ble Courts. Ensuring compliance of the orders by each of the ISPs is a time-consuming and complex task especially in view of multiplicity of orders of Hon'ble Courts, multiplicity of websites to be blocked and multiplicity of ISPs.

2. Allocation of Business Rules inter-alia states thus:-

*'Policy matters relating to information technology; Electronics; and Internet (all matters other than licensing of Internet Service Provider).'*

3. In view of above and in order to ensure effective removal by content for viewing by public at large, the plaintiff is requested to do a trace route of the web server hosting the said website. In case the web server happens to be in India, the plaintiff may inform the same to Meity who may direct the owner of such web server to stop transmission of content as per IT Act and as directed by the Hon'ble Court so that the content would be blocked from the source itself and the exercise of blocking by 2700 ISPs would not be required.

4. In case such server is located abroad i.e. outside India then access to such URL/website can be blocked through the international internet gateways which are much less in number. This would result in timely and effectively removal of undesirable content for viewing by public at large as is the requirement as per the orders of Hon'ble Court.
