Subject: Charging of fee for Acceptance Testing of Mobile Number Portability

This is regarding the charging of fee for Acceptance Testing (A/T) of networks of various Telecom Service Providers (TSPs) for Mobile Number Portability (MNP) service which was carried out by the Telecom Enforcement Resource and Monitoring (TERM) Cells. Pending the decision on MNP A/T fee an undertaking was taken from all TSPs to deposit the fee for MNP as and when decided by DoT.

2. The competent authority has now decided that the MNP A/T fee to be charged for various types of networks will be as below:

* Network - Wireline, WLL, GSM Mobile network, CDMA mobile network are four distinct networks of Access Service providers.

- ** Fee of MNPO is applicable only for MNP Acceptance Testing of GSM / CDMA based mobile network and it is not applicable for Wireline / WLL Network and ILD gateway Testing.
- 3. If an Access Service Provider is offering different type of Network for MNP in the LSA i.e. GSM Network, CDMA Network and wire line network for the MNP A/T then separate fee for each network is to be charged. Similarly, the portion of MNPO will be charged as per above mentioned table for each network as applicable.
- 4. In case of MNPO, separate fee is to be charged for MNP A/T for Main Site and Disaster Recovery Site. The fee for ILD service licensee is for MNP A/T of per gateway and shall be paid in the respective LSA where gateway is located.
- 5. The fee is to be deposited within seven days from the date of issue of demand note by TERM cell where A/T has already started/ completed. In other cases fee is to be submitted along with the offer for A/T.

6. Fee per network per LSA is to be submitted to the TERM Cell in the form of Demand Draft drawn on any scheduled bank in favour of CAO O/o the concerned CCA in the LSA. The licensee should ensure that the demand draft is valid for six months. The Demand Draft for the different service areas should be drawn as given below: (For example, one who is applying for Gujarat will draw Demand Draft in favour of CAO O/o CCA, Gujarat payable at Ahmedabad)

- 7. Any delay in payment of the fee beyond the stipulated period will attract interest at a rate which will be 2% above the Prime Lending Rate (PLR) of State Bank of India prevalent on the day the payment became due. The interest shall be compounded monthly and a part of the month shall be reckoned as a full month for the purpose of calculation of interest. A month shall be reckoned as an English calendar month.
- 8. In case of re-offer of A/T due to failure in full or part for any network, fee as prescribed shall be payable again by the concerned service provider for that network.
