

- (a) Copy of letters issued by the Steering Committee to various Association / Federations inviting suggestions in this regard.
 - (b) Copy of suggestions submitted by various Association/Federation including AIPAEA. (AIPAEA suggested 35% quota to PAO and CCA officials through qualifying exam, 35% to Postal officials through competitive exam and 30% SCF quota to Sr. Accountants of PAO and CCA offices on all India basis which was modified by Steering Committee as 40:40:20 ratio respectively).
 - (c) Copy of the final recommendations of that Steering Committee in r/o framing R.R. for AAO Cadre. After much deliberations. Steering Committee recommended the ratio of 40% to PAO & CCA officials through Departmental exam, 40% to postal officials through Competitive exam and 20% on SCF basis to Sr. Accountants of PAO and CCA offices. Subsequently the then new DDG (PAF) was particular in introducing DR element and therefore, it was told that 40% DR quota introduced ^{by} replacing the 40% provided to postal colleagues by the Steering Committee.
