OFFICE MEMORANDUM

Subject : **Filling up of five (5) posts of Deputy Financial Advisors (Dy. FAs) in CRPF on deputation basis – reg.**

The undersigned is directed to say that Central Reserve Police Force (CRPF), a Central Armed Police Force is an attached officer under administrative control of this Ministry, having all India liabilities, has been authorized five (5) posts of Dy. Financial Advisor (DFA) i.e. one (1) at Headquarter Delhi and one each at Jammu, Kolkata, Guwahati and Hyderabad Zones.

2. CRPF has been delegated substantial financial powers, which have to be exercised with the concurrence of DFA at the Zonal level. As, for effective functioning of DFA, technical competence in Public Financial management as well as functional independence is essential. Therefore, for smooth and efficient functioning of Internal Finance Unit of CRPF, the services of officers who have exposure and experience of work in the Central Civil Ministries and PFMS are required.

3. As per the RRs, the posts of DFAs in CRPF are to be filled up by deputation of officers of the Central Government belonging to any of the Organized Accounts Services and the post of DFA carries scale of pay in Level-12 (Rs.78,800-2,09,200) in Pay Matrix. The officers holding analogous posts in the pre-revised pay scale of Rs.15,600-39,100+GP 6600 in PB-3 (revised Pay Matrix Level-11) are eligible for the post of DFAs in CRPF on deputation basis.

4. In spite of making all out efforts to fill up the post of Dy. FA from officers from Central Government by advertising in leading news papers, the vacancies in the rank of Dy. FA to be filled through deputation have remained unfilled due to non availability of suitable officers. As such, the five (5) posts of DFAs are lying vacant in CRPF since long and financial administration of CRPF is being hampering badly.

5. In view of the facts explained above, the undersigned has been directed to request Cadre Controlling Authority (CCA) of Organised Accounts Services to kindly offer comments, as to whether, the officers from your departments/ organizations, having work experience in the Central Civil Ministries could be sponsored on deputation to CRPF for the post of Dy. Financial Advisor.

6. In addition, CCAs are also requested to offer their comments on encadrement of posts of Dy.FA in their Cadre so that officers from the Cadre can be posted straightaway without resorting to deputation.
