I.A. 39746/2024-by plaintiff for modification of order dt. 24.05.2024.

1. By virtue of the present application, plaintiff seeks the following reliefs:-



1. *Allow the present application and modify the Order dated 24 May 2024 to remove the domains asianpaintslogin.com, asianpaintsservices.com and asianpaintsservicesmktg.com from the list of infringing domains at Annexure-A;*
 2. *Issue directions to the Defendant No. 8, GoDaddy .com LLC to remove all locks and revoke suspension of the domains asianpaintslogin.com, asianpaintsservices.com and asianpaintsservicesmktg.com;*
 3. *Issue directions to the Defendant Nos. 23 (Ministry of Electronics and Information Technology/ MeitY) and 24 (Department of Telecommunications/ DoT), to recall blocking directions issued to necessary internet service providers as directed vide order dated 24 May 2024 pertaining to the domains asianpaintslogin.com, asianpaintsservices.com asianpaintsservicesmktg.com so that access to the domains/ websites is restore.*
2. It is the case of the plaintiff that the above three domains were inadvertently given in the list of infringing domains and are in fact belonging to the plaintiff itself.
3. Issue notice.
 4. Learned counsel for the defendant no.8 accepts notice. He submits that the locks and suspension *qua* all the three domains shall be revoked within a period of two weeks.
 5. Accordingly, in view of the submissions made by the learned counsel for the parties and averments in the present application, this Court feels it appropriate to also direct the defendant nos. 23 and 24 as well to recall the locking directions issued to the necessary internet service providers pertaining to the three domain names so that access to the said three domains is duly restored within a period of two weeks.



6. In view thereof, nothing survives in the present application. The same is accordingly disposed of with the aforesaid directions.

7. By virtue of the present application, defendant no.8 seeks modification/ clarification of the paragraph 9(iii) of the order dated 24.05.2024 passed in IA. No. 30311/2024.

8. Issue Notice

9. Learned counsel for the plaintiff accepts notice and submits that he has no objection to the present application being allowed.

10. For the reasons stated, the present application and arguments advanced by the learned counsel for the parties the present application is allowed and the paragraph 9(iii) is modified and to be read as under:-

*“(iii) the Defendant Nos. 8, 9, 11, 35, 37, 42, 46 and 58-73 [Domain Name Registrars] are directed to **lock and suspend** access to the domain names mentioned in Annexure-A of this order, which are registered with them. They shall, within four weeks from today, file in a sealed cover, the complete details KYC details of the registrant, as are available with them. A copy of the said documents shall also be provided to counsel for Plaintiff, which shall be strictly used by them for the purpose of investigation and identification of the perpetrators.”*

11. Needless to say, the order dated 24.05.2024 and the present order will be read in conjunction with each other.

12. Accordingly, the present application stands disposed of in the aforesaid terms.

Subject: Action requested to be taken by MEITY and Plaintiff for effective removal of content for viewing by public at large within India as per the said orders of Hon'ble Court.

It is observed that a number of orders of Hon'ble Court are issued for blocking of websites every month. There are around more than 2700 ISPs in India and these ISPs are connected among themselves in a mesh network. DOT is instructing each of the ISPs through emails/through its website for blocking of the websites as ordered by the Hon'ble Courts. Ensuring compliance of the orders by each of the ISPs is a time-consuming and complex task especially in view of multiplicity of orders of Hon'ble Courts, multiplicity of websites to be blocked and multiplicity of ISPs.

2. Allocation of Business Rules inter-alia states thus:-

'Policy matters relating to information technology; Electronics; and Internet (all matters other than licensing of Internet Service Provider).'

3. In view of above and in order to ensure effective removal by content for viewing by public at large, the plaintiff is requested to do a trace route of the web server hosting the said website. In case the web server happens to be in India, the plaintiff may inform the same to Meity who may direct the owner of such web server to stop transmission of content as per IT Act and as directed by the Hon'ble Court so that the content would be blocked from the source itself and the exercise of blocking by 2700 ISPs would not be required.

4. In case such server is located abroad i.e. outside India then access to such URL/website can be blocked through the international internet gateways which are much less in number. This would result in timely and effectively removal of undesirable content for viewing by public at large as is the requirement as per the orders of Hon'ble Court.
